News and Updates

The Flood Protection Authority Board at its December 21st Meeting authorized the execution of the Cooperative Endeavor Agreement amongst the FPA, CPRA and New Orleans Sewerage and Water Board for assuming management and operation responsibilities of the Permanent Canal Closures and Pumps (PCCP). FPA staff is formulating a plan for the maintenance and operation of the PCCP, which is anticipated to be turned over by the Corps of Engineers by the end of February.

The next phase of the Leadership Training Project will be rolled out to all supervisors and specific other staff beginning the first week of January.

The audit of the FPA's financial statements for the Fiscal Year ending June 30, 2017 has been completed and the audit firm of Carr, Riggs and Ingram has issued a clean report for the FPA with no findings.

Digital Message Boards have been ordered and will be installed in all FPA locations in January. IT staff is researching live-streaming Board meetings to the message boards.

IT recently ordered Dell all-in-one desktop work stations that will allow employees to check their emails and gain access to on-line/e-learning activities at a designated work space. The work stations are anticipated to be deployed by February.

Glenda Boudreaux has been appointed communications facilitator, and will drive frequent substantive communications broadly to team members. Various methods will be utilized, as appropriate, to communicate information to employees, such as e-mail blasts, electronic message boards, *In the Levee Loop*, and by distributing copies. Suggestions, ideas and information regarding the FPA's distribution methods can be submitted by email to gboudreaux@slfpae.com or placed in the *In the Levee Loop* suggestion boxes. Also, suggestions can be submitted by visiting the FPA's website (floodauthority.org) and clicking on the "Suggestion Box" tab located at the bottom of the home page.

Members of I-Storm (an international group of storm surge barrier owners/operators) will conduct an independent peer review of the IHNC Surge Barrier and Seabrook Complex in May, 2018.

The EJLD Lakefront Levee lifts are completed and the U.S. Army Corps of Engineers' (USACE) contractors have begun the armoring of all five EJLD Lakefront Levee reaches. The USACE will advertise the consolidated levee lift/armoring projects for LPV 109.02 and LPV 111.1 located in New Orleans East in February.

Tchoupitoulas Street Floodwall Murals Project



New Orleans International Muralists, LLC

Dedicated to cultural preservation through art and education

The final permit (OL2017-014) has been issued to the New Orleans International Muralists, LLC (NOIM) by the Authority granting permission to paint a mural on the Tchoupitoulas floodwall between Josephine Street and 9th Street. This will be the first mural project approved by the Orleans Levee District since 1890.

The overall goal of this project that coincides with the 300th anniversary of New Orleans is to depict the history of the city and represent all of the ethnic groups and genders that were and have been resilient in building New Orleans. Daniel J. Pate and Jamar D. Pierre are spearheading the historic project and are cultural gatekeepers who were both born and raised in New Orleans. They have both been very involved in giving back to the City through education endeavors, community activism and public art projects.

Artist Pierre said that "the Tchoupitoulas Street floodwall is a perfect location to paint a mural large enough to tell a story that helps preserve the past, present, and give an artistic insight of what type of future New Orleans could have. With the city we all love to claim and nurture on the brink of its 300th anniversary, the timing for this couldn't be better for a mural of such historic significance."

NOIM has been planning and meeting with local artists, USACE, FPA staff, local officials, and others within the arts communities for this mural for over three years. In order to exhibit the city's rich history with great detail using talented artists, funding substantial enough to create a mural along the approximate 1.5 mile stretch of floodwall is still needed. The mural will be painted one block at a time as funding provides. Each floodwall panel will illustrate at least one and upwards of three important historical events. By working with their selected groups of artist this project is anticipated to take between 18 and 24 months (weather permitting). Funding is still needed for each city block, estimated between \$50-60,000 per three floodwall panels for a total budget of \$450,000. Corps of Engineers Schedule for 2018 Annual Inspection

The U.S. Army Corps of Engineers has issued its schedule of Annual Inspections for the Hurricane and Storm Damage Risk Reduction System (HSDRRS) and Mississippi River Levees (MRL).

Tuesday, March 13—Inspect HSDRRS levees and MRL in Orleans Parish in the New Orleans East Bank System (St. Bernard Subbasin).

Thursday, March 15—Inspect MRL and floodwalls and the Seabrook Complex in Orleans Parish in the New Orleans East Bank System (Orleans Metro Subbasin), and, if time permits, the IHNC West floodwall

Wednesday, March 21—Inspect completed HSDRRS levees in the New Orleans East Bank System (Orleans East Subbasin).
