Start Preparations Now for Hurricane Season

Before you know it, hurricane season will be here. The season officially begins on June 1st and the FPA is making plans, preparations and gearing up to be ready for action come June 1st. It's not too early to begin making personal plans and preparations for the upcoming hurricane season. Researchers at Colorado State University predict 2018 will be a slightly above-average season with 14 named tropical storms, seven hurricanes and three major hurricanes. However, we need not be reminded that we only need one major storm to cross our path to result in a devastating hurricane season for us.

Communication is a vitally important component of hurricane preparation. Prepare in advance for evacuation. All employees should update their Emergency Contact Forms with their most current contact information, including cell phone number, personal email address, and evacuation location and telephone number. These forms are maintained by the Flood Protection Authority's Human Resources Department. Employees who remain on duty should prepare for the evacuation of their family. Employees can notify Kaz in the IT Department (kaz@floodauthority.org) of any changes in their cell phone information (provide new number and carrier) in order to receive text messages from the Flood Protection Authority.

News and Updates

The FPA's new web-based permitting system is scheduled to be completed by the end of April. The system was designed by Vinformatix with funding for the project provided by a Community Block Grant.

New timeclocks have been received. The various processes and procedures required for the new timeclocks are being developed and implemented by the Finance Department. Clocks have been installed at the LBBLD and will serve to test the new system. Upon successful completion of the test, timeclocks will be rolled out

to the remaining locations. The timeclocks are anticipated to be fully operational across the Authority by the end of April.

The email migration across the Authority has been completed. All FPA team members will have email addresses at @floodauthority.org.

The FPA's new Dell all-in-one desktop (Kiosk) work stations will allow all employees currently without computer access to check their emails and gain access to online/e-learning activities. Work stations will be set up in the following areas: three in the newly renovated O.L.D. Levee Maintenance area, one at the LBBLD, two at the EJLD (one each in the Mechanic Shop and Police conference room), and one at the Lake Vista Community Center for O.L.D. Police personnel. The work stations are anticipated to be fully functional by the end of April.

Information Technology Policies are being developed to promote and enforce the Authority's basic mission and to ensure that appropriate measures are put in place to protect the FPA's IT infrastructure.

The updated Purchasing Policy was approved by the Board on March 15th. Work is being done to centralize most of the purchasing activities at the Franklin facility and to automate the purchase order issuance process.

The first edition of the Flood Protection Authority's quarterly Newsletter was issued the first week of April. The newsletter is a part of the FPA's public outreach effort. The purpose of the quarterly newsletters is to inform public officials, civic associations, the media and communities about the FPA's mission and how we are fulfilling that mission, how tax dollars are being spent, and news about FPA projects and activities. The Newsletter will be emailed to a subscription list and placed on the website.

The Architect for the O.L.D. Franklin Facility Renovations Project finalized the specifications for the modular/movable wall and furniture system. Bids were requested in March on the wall/furniture system. The advertisement for bids for the construction of the renovations is planned to take place in April.

The reconstruction of the Pump Station 5 office in Lake Borgne is almost completed. Thanks to the FPA team members who worked hard to provide a safe, suitable workspace for their colleagues. On the right are pictures of the newly renovated PS 5 office.

The EJLD and O.L.D. Police Departments recently entered into an inter-departmental relationship with the United States Coast Guard, St. John Sheriff's Office and the Port Authority of South Louisiana. Our Levee District Police are committed to a joint Task Force working with the Maritime Security Operations Initiative.

The program is directed by the United States Coast Guard and allows for the cooperation of Federal, State, County (Parish) and Municipal agencies to assist in the enforcement, protection and safety of the River Region. The program is administered by Port Authority supervisor, Mr. "Tootie" Noel. Under the direction of Mr. Noel, officers get the unique opportunity to see the other side of the levee systems that they patrol. In turn, maritime personnel see what the Levee District Police see, from the land areas of the Levee System.

Our Police personnel meet every Wednesday morning at the Port of Louisiana Global Complex in Reserve, La. One officer from each agency boards a Security Maritime Patrol vessel at this location and a sweep of the Mississippi River is performed looking for possible danger and Homeland Security locations of interest. This exercise also avails all departments to monitor high river levels, identify encroachment issues and surveys the Mississippi River Levee System for any issues of concern.

This relationship supports multiple agencies working together, towards a common goal of Safety and Security along the waterways and land masses of the Mississippi River System.

WDSU accompanied our personnel on the exercise that took place on March 7th to see what our Officers see during high water and to understand the importance of these maritime exercises.



Police Employee of the Month for March



Michael Brenckle was nominated and selected as Police Employee of the Month. Michael is a Police Officer 2A in the EJLD Police Department.

On Thursday February 15, 2018 at 2251 hrs, Officer Brenckle was at the Bonnabel Boat Launch when he heard a woman screaming for help. He determined that the screams were coming from a 2000 Nissan Xtera and observed a woman walking briskly toward him with a male subject close behind. Upon making contact with the subjects Officer Brenckle detained and identified the male subject. Upon investigation it was determined that the victim and the suspect were romantically involved and that he had forcedly abducted her from in front of her residence. In her statement the victim related that the suspect

approached her as she was walking to her apartment and that she did not want to talk to him, which angered him. He struck her, pulled her hair, choked her and forced her into the vehicle. As the suspect was driving, the victim attempted to exit the vehicle at which time he pulled over, struck and choked her again. The suspect also made threats against the victim's life, stating that if she wasn't going to give him a chance that he might as well kill her.

As officers attempted to place the suspect in the rear of unit 140, the suspect became resistant, and a brief struggle ensued. The suspect was eventually able to be secured in the rear of the unit. The suspect was charged with LRS 14:45 Simple Kidnapping, 14:35.3L Domestic Abuse Battery (Gwens Law) and 14:108 Resisting arrest.

It is Officer Brenckle's alertness, professionalism and dedication to duty that the victim's life was most probably saved. Officer Brenckle is a great asset to the FPA and the community.

FPA Team Receives Active Shooter Response Training

CHIEF NAJOLIA PROVIDES VITALLY IMPORTANT INFORMATION ON A SUBJECT OF CRITICAL IMPORTANCE IN THIS DAY AND AGE

Kerry Najolia, the FPA's Police Superintendent, gave a dynamic presentation on "How to Survive an Active Shooter Event" to a captivated audience of Authority employees. His voice reverberated around an otherwise silent room. Chief Najolia passionately projected in no uncertain terms "When an active Shooter is in your area you must be prepared both mentally and physically to deal with the situation." You have only three options: Run, Hide or Fight in that order. You cannot hesitate to act. You cannot wait for the Police to arrive. Approximately 60 percent of incidents end before the police arrive. The presentation was given at the FPA's Orleans, East Jefferson and Lake Borgne Divisions. Thank you Chief Najolia for your time and effort...you may have just saved a life.

FPA Public Outreach—Pilot K-12 School Program

Flood Protection Authority's K-12 School Pilot Program

St. Bernard Parish Public Schools

The K-12 School Program is part of the Flood Protection Authority's public outreach to enhance understanding of its mission. The purposes of the school program are to ensure that future generations are equipped to deal with the risks and challenges associated with living with water, gain an in-depth knowledge of the flood protection system, and share their learning experiences with family and friends.

The Pilot K-12 School Program was developed and taught by Anne Rheams, FPA Public Education Consultant, in collaboration with Doris Voitier, St. Bernard Parish Public Schools Superintendent, the school board's Science Director, Gena Acevedo, and 8th grade science teacher, Alisha Capstick at Trist Middle School in Meraux. Alisha was recently awarded Science Teacher of the Year by the Louisiana Science Teachers Association. Thirty, 8th grade students participated in the program throughout the month of January.

The curriculum was developed in accordance with the National Next Generation Science Standards and the Louisiana Department of Education's Performance Expectations. The lessons and activities are based on the 5 E's learning model (engage, explore, explain, elaborate, evaluate). Major topics covered in the program are: Geographical Orientation (where do the students live in relation to the water surrounding St. Bernard); Storm Surge (what is the science behind it); the Hurricane and Storm Damage Risk. Reduction System (where and what is it); the Lake Borgne Surge Barrier (field trip and model building); Risk Reduction (what is it and how can they protect themselves and educate others). Students participated in a number of classroom activities under each topic resulting in a comprehensive understanding of flood protection and risk reduction.

The Flood Protection Authority anticipates future development of the program for schools in East Jefferson and Orleans Parishes.

Riding Along With the 313!

Over the past few weeks I have had the opportunity to "ride along" with Department 313 in Orleans Parish. My normal duties keep me behind a computer, so this was a special treat and one that I will repeat in East Jefferson and Lake Borgne. My first ride along was for the Corps' Annual Inspection of the Lakefront Polder. Carol Barriere was my tour guide and he did not disappoint. My first impression of Carol was that of a multi-tasking, air-traffic controller. He was on his cellphone and had no less than two people on the radio at all times making sure that everything was coordinated. That brings me to the Team Members of Department 313. All I can say is WOW! Their performance during the Corps' Annual Inspection was nothing short of award-winning. Monica Hall, Mike Leblanc & Lavell Lane made sure that every instruction given by Carol was carried out perfectly. Brian Lee, Todd Polk, Keanon



Brisco, Vashon Hall, Sergio Cardenas, Jeremy Coubarous, Darrell Dempsey, Jeff Johnson, Rontrell Jones, Deron Moore, Wendell Lewis, Roy Moss, Michael Redditt, Charles Williams, Jeffery Beverly, Tyus Long and Christopher Neyland all made sure debris was removed from levees/floodwalls, that sandbags were in place, that grass was trimmed and that our caravan never had to wait in traffic. If our levee district police officers ever need extra hands to assist with traffic flow management, they should call one of these guys. An inspection that in the past has taken two days took five hours because of the precision and hard work of Department 313 Team Members. At the end of the inspection, the Corps praised the work of these gentlemen and woman (Go Monica!) for the condition of our levees and how quickly we were able to get through the inspection.



My second ride along was also with Department 313 so that I could get a feel for what they do on a daily basis. I never want to hear anyone refer to these Team Members as "just grass cutters." They are so much more than that. They are snake charmers, alligator wranglers, landscape architects and a construction crew all rolled into one. They get up at 4:00 am to be at work and out the door by 6:30 am. They work in 100 degree heat and freezing cold and they are our first line of defense for flood protection. I had no idea of the attention to detail that is required. Not only does our Team look for major issues like sand boils and erosion, but they also look for grass growing out of small cracks and rodent holes that look small but can actually burrow 4' or more into the levee, which can significantly impact it if not filled. It takes

some kind of skill to navigate a zero-turn mower on a 90 degree slope – where you may encounter a snake or alligator, both of which we saw while out in the field. We watched Steve Durr's crew open and close a flood gate on Highway 11. They had some difficulty getting it re-opened. However, they kept working on that gate until they got it opened. Monica Hall's Team had multiple dump trucks that were trying to get to an area that

needed to be filled with clay. It was so muddy the trucks could not make it in. But, instead of giving up for the day, they brought in bulldozers and were moving earth to get to the site. What I saw on both of these days in the field were Team Members who were professional, proud, determined and committed to their jobs.

This entire experience has left me impressed and grateful for the work that our Team does to keep us dry. I look forward to seeing what our Teams in Lake Borgne and East Jefferson can teach me.

LASERS Prep Workshops
