#### Louisiana Legislature

The LA Legislature adopted Act No. 490, which authorizes Levee Districts to pay its Police Officers an amount equal to the State's Supplemental Pay. Officers must be full time, P.O.S.T. certified and have completed one year of service with the Levee District. Act No. 490 becomes effective on August 1, 2018.

The Flood Protection Authority has attempted for a number of years to obtain authorization to provide the additional compensation that is currently paid to municipal police departments, sheriffs offices and numerous other agencies.

Legislators realized that our Officers operate within major metropolitan areas and are faced with the same challenges and risks as Federal, municipal and State law enforcement officers. Flood protection infrastructure for metropolitan areas in many instances is located adjacent to parkways, recreational areas, highways and roadways frequently used by the public. Levee District Police Officers partner and assist Federal, State and municipal police agencies whenever possible for the benefit of public safety. They not only patrol and secure levees, but must secure major complex flood defense structures valued in the tens to hundreds of millions of dollars. As with any type of urban infrastructure, flood defense infrastructure protecting major metropolitan areas is subject to security risks and requires heightened security measures. And, last, but certainly not least, our Levee District Police Officers remain on active duty and act as first responders during and after hurricane and storm events.

Chief Kerry Najolia expressed the Police Department's appreciation of the support of the Flood Protection Authority team and Board of Commissioners.

#### **I-STORM Peer Review - Promoting O&M Excellence**



The Flood Protection Authority joined I-STORM, the International Network for Storm Surge Barriers, in 2012. Last fall the FPA requested an I-STORM peer review of our major storm defense complex structures. The peer review started on May 12th and ended on May 21st with a presentation on the team's findings.

The goals of an I-STORM peer review are to promote the highest level of excellence in operation, maintenance and management of storm surge barrier assets by identifying areas for improvement, strengths and best practices, and to continue the development of an international network of surge barrier professionals through which knowledge, expertise and experience can be shared.


The team included twelve members from the United Kingdom and the Netherlands, along with three Corps of Engineers and three FPA staff members. The team spent three days in the field, in record breaking heat, inspecting the IHNC Surge Barrier Sector Gate, Barge Gate, Bayou Bienvenue Sector Gate and the Seabrook Complex Gate Structure. Team members took hundreds of pictures documenting every aspect of the structures and developed a list of over 600 on-site facts identifying areas that need improvement and best practices that can be shared with I-STORM members.

The team met over the next several days pouring over and evaluating the 600+ collected facts with the skill, expertise and seriousness consistently exercised by this unique group of professionals that included environmental scientists, and electric/electronic, civil, mechanical, hydraulic and coastal engineers. The team developed a fifty page draft report with 203 pages of appendices. A final report will be submitted to the FPA by I-STORM.

The FPA is truly grateful for the opportunity to receive such a thorough professional evaluation of its critical flood defense infrastructure.
