MINUTES OF THE SOUTHEAST LOUISIANA FLOOD PROTECTION AUTHORITY-EAST BOARD MEETING THURSDAY, JUNE 14, 2018

The regular monthly Board Meeting of the Southeast Louisiana Flood Protection Authority-East (Authority or FPA) was held on June 14, 2018, in the Franklin Avenue Administrative Complex, Meeting Room 201, 6920 Franklin Avenue, New Orleans, Louisiana, after due legal notice of the meeting was sent to each Board member and the news media and posted.

Mr. Hassinger called the meeting to order at 11:10 a.m. and led in the pledge of allegiance. Mr. Kemp called the roll and a quorum was present:

EMPLOYEE RECOGNITION AND APPRECIATION:

Mr. Hassinger explained that the success of the organization depends on the people who work at the FPA. Therefore, the Board takes the opportunity each month to recognize a member of the FPA team who is exemplary and dedicated to the FPA's mission. It is people like Tyus Long, who are committed to their job and do excellent work, that make the FPA a success.

Tyus Long was nominated by his fellow team members in Group 313 for Employee of the Month. Mr. Long began his career at the Flood Protection Authority on September 28, 2015. He was very curious and eager to learn as much as he could about the flood protection system and its levees, floodwalls and floodgates, and how the various components of the system are maintained. He learned to use the equipment needed for grass maintenance and, along with his co-workers, how to properly use Herbicide equipment, at which he excelled. Mr. Long can be counted on to be at work every day and always schedule leave in advance when needed. Mr. Long is always asked for by all the foremen in 313 because he is very dependable and trust worthy. He is currently working to obtain his driver license to further his career at the FPA. Mr. Long exemplifies the values of the FPA in his day to day activities and plays an important part in ensuring the integrity of the flood defense system.

Mr. Hassinger thanked Mr. Long for his service and presented a Certificate of Commendation to him.

NOMINATION AND ELECTION OF OFFICERS OF THE BOARD FOR A ONE YEAR TERM EFFECTIVE JULY 1, 2018_____

The floor was opened for nominations for the office of President. Mr. Luettich offered and Mr. Latiolais seconded the nomination of Lambert J. Hassinger, Jr. There were no further nominations. Mr. Hassinger was elected to fill the office of President by a unanimous vote of the Board.

The floor was opened for nominations for the office of Vice President. Mr. Hassinger offered and Mr. Miller seconded the nomination of Richard A. Luettich, Jr. There were no further nominations. Mr. Luettich was elected to fill the office of Vice President by a unanimous vote of the Board.

The floor was opened for nominations for the office of Secretary. Mr. Miller declined the nomination offered by Mr. Luettich for the office of Secretary. Mr. Miller offered and Mr. Latiolais seconded the nomination of Clay Cosse. There were no further nominations. Mr. Cosse was elected to fill the office of Secretary by a unanimous vote of the Board.

The floor was opened for nominations for the office of Treasurer. Mr. Miller offered and Mr. Luettich seconded the nomination of Mark L. Morgan. There were no further nominations. Mr. Morgan was elected to fill the office of Treasurer by a unanimous vote of the Board.

RESOLUTION NO. 06-14-18-02 - ELECTION OF OFFICERS

"A resolution stating the results of the election of Officers of the Southeast Louisiana Flood Protection Authority-East for a term of one year commencing July 1, 2018."

WHEREAS, the Board adopted revised Bylaws at a Regular Board Meeting held on December 17, 2009, which provide in part for the designation and election of Officers of the Board; and

WHEREAS, Article IV, Section 1 (Officers and Elections), designates the officers as President, Vice President, Secretary and Treasurer to be elected from among the members of the Board at the regularly scheduled June meeting; and

WHEREAS, Article IV, Section 1 further provides that officers shall assume their duties on July 1st; and

WHEREAS, Article IV, Section 2, provides that officers shall be elected to serve one year terms.

WHEREAS, an election of officers was conducted on June 14, 2018, with nominations for each office duly offered and seconded and a vote conducted thereafter to fill each office.

OPENING COMMENTS BY PRESIDENT AND COMMISSIONERS:

Mr. Hassinger advised that the Business Council of New Orleans hosted a public education event to discuss the status of the flood defense system. Speakers included Mr. Hassinger, Col. Michael Clancy, Commander-District Engineer, U.S. Army Corps of Engineers (USACE), Ignacio Harrouch, Chief of Operations, Coastal Protection and Restoration Authority (CPRA), and Susan MacClay, Chair, FPA-West. The collaborative effort that takes place on a day-to-day basis to ensure appropriate flood protection for the region was discussed.

Mr. Hassinger explained that at the event Col. Clancy was able to better explain the USACE's minimally acceptable rating of levee systems. Col. Clancy acknowledged that the terminology is confusing and that he did know where the term originated. Col. Clancy explained that the designation of "minimally acceptable" means that the system

is acceptable and that there are day-to-day minor transient conditions that do not affect the capability of the system to perform. The point was stressed that quarterly, semiannual and annual inspections are performed and that the FPA has people on the system every day. The purpose of the inspection is to identify conditions that need to be addressed. The fact that conditions are identified means that the inspections are a success. The event ended with a question and answer session.

Mr. Luettich added that Mr. Hassinger did a good job of reiterating the FPA's approach of full transparency and that the inspection reports are now being posted on the FPA's website. Mr. Hassinger explained that a statement had been made implying that requests were made of the FPA to produce the USACE annual inspection reports and that the FPA had failed to fulfill the request. However, the FPA did not receive any such requests. Therefore, the reports in their entirety, along with the FPA's responses, were posted on the FPA website. The FPA will post the reports on its website each year going forward.

PUBLIC COMMENTS:

Edward Feinman explained that he has lived along the 17th Street Canal for over fifty years. Several years ago the USACE removed the trees along the toe of the levee and required Mr. Feinman to move back his fence. Therefore, a four to five foot wide section of the levee toe remains under title to him; however, he has no control over the area. He expressed concern about the legality of selling his property in the future, should he chose to do so, since he has title to the area, but no control over it. An additional concern is liability. Should someone get hurt in the unfenced area, Mr. Feinman feared he could potentially be held liable. Mr. Feinman stated that he felt that the Board was violating several State laws by controlling his property, but not purchasing or taking title to the property. He also commented on the lack of maintenance in the section of levee between the floodwall and the water's edge.

Mr. Feinman also expressed concern about whether the 17th Street Canal could handle the increased pumping by Jefferson and Orleans Parishes and their plans for future enhancements to pump even more water into the canal. He pointed out that there has been a five foot drop in the water table in Lakeview. He recommended that the FPA review the relationship between the canal and drainage and that additional coordination take place with the Sewerage and Water Board of New Orleans (S&WB) to determine the future capacity of the 17th Street Canal.

Mr. Feinman pointed out that the USACE completed the Permanent Closures and Pumps (PCCP) project, which will prevent tidal surge from the lake from entering into the 17th Street Canal.

Mr. Hassinger requested that Mr. Feinman contact the FPA's Executive Counsel regarding the property issue. Mr. Feinman explained that he had spoken with the FPA's Executive Counsel in the past and did not have any confidence in the result.

John Riehm advised that he attended Wood Materials' ribbon cutting ceremony on May 9th for the concrete haul road along the river in Harahan. Pierce Wood stated at the

ceremony that he was waiting on a quote for grading the old haul road along the levee and that the work should be accomplished within weeks along with the work on the berm and tree curtain. The work is anticipated to begin on July 9th.

Evelyn Riehm commented on a May 13th Advocate article regarding the old haul road along the levee and the new haul road along the river. The concrete road along the river is about 1,000 feet farther away from nearby Harahan residences than the old dirt road. Wood started using sand pit four after sand pit three filled with water and was closed. Instead of remaining on the concrete haul road, trucks are exiting the concrete road and driving along the sand between pits three and four creating airborne sand. She requested that the FPA look into this situation.

Mr. Hassinger requested that Mrs. Riehm contact the FPA's Chief Administrative Officer regarding this issue.

Mr. Cosse stated that he was asked to read a letter, copy appended to the minutes, from former Commissioner Timothy Doody.

PRESENTATIONS:

None.

COMMITTEE REPORTS:

Finance Committee: Mr. Morgan reported that the Finance Committee met prior to the Board meeting. The Committee considered and discussed the following items:

- Fiscal Year (FY) 2018 budgets and proposed budget revisions.
- The proposed selection of the Times Picayune as the official journal for the FPA, East Jefferson Levee District (EJLD) and Orleans Levee District (O.L.D.) and the St. Bernard Voice as the official journal for the Lake Borgne Basin Levee District (LBBLD).
- The completed Louisiana Compliance Questionnaires for FY 2018.
- Signature authorizations for current Community Development Block Grants.
- A proposed Intergovernmental Agreement between the EJLD and Jefferson Parish for FY 2017 State Homeland Security Grant Program funding in the amount of \$3,316.00 to purchase surface water operations equipment for use by EJLD Law Enforcement.
- Renewal of the Professional Services Agreement with Water Management Communications for FY 2019 in order to continue development and implementation of the Education and Public Outreach Program.
- Report by the Internal Auditor on the LBBLD's use of trustees. The services of the St. Bernard Parish Sheriff's Office had been terminated due to the insufficient benefit received. The service can be reconsidered in the future should the situation change.

<u>Operations Committee</u>: Mr. Miller reported that the Operations Committee met prior to the Board meeting. The Committee discussed and recommended that the Board approve all of the items on the Operation Committee agenda with the exception of the award of a contract for the demolition of the Loft Building, which was deferred since the bid period was extended.

<u>Coastal Advisory Committee</u>: Mr. Kemp advised that the Coastal Advisory Committee had not met since its meeting on May 16th.

Mr. Hassinger addressed committee assignments for the new term commencing on July 1st. He asked that Commissioners advise by email should they wish to serve on a particular committee.

<u>CHIEF ADMINISTRATIVE OFFICER'S REPORT</u>: Derek Boese, Chief Administrative Officer (CAO) provided the highlights of his report:

- Critical information requirements have been developed so that the appropriate chain
 of command is informed regarding various incidents or situations. The requirements
 will be communicated to employees via email and the employees' newsletter. Sixtytwo resumes were received and are being reviewed for the position of Public
 Information Director.
- Revised safety policies are being developed. A tractor-train accident (no serious injuries) that occurred on June 12th outside the entrance to the LBBLD shop is under investigation for cause. In the past investigations primarily focused on punitive actions. Investigations now focus primarily on determining the root causes of incidents, determining trends and developing best practices.
- Emergency Operations Center (EOC) upgrades have been completed. FPA staff participated in the USACE Hurricane Exercise conducted on June 5th. The FPA anticipates conducting an internal Hurricane Exercise in late June. Radio check procedures are being finalized.
- In anticipation of Tropical Storm (TS) Alberto, the FPA closed 18 low sill gates along the Industrial Canal and coordinated PCCP operations with the S&WB and CPRA. The new communication plan developed in cooperation with the Port of New Orleans, wherein the Port notifies tenants regarding gate closures, worked smoothly for TS Alberto.
- PCCP Remote monitoring capabilities have been established between each pump station and the Franklin EOC. The information can be broadcast to CPRA, S&WB and other appropriate entities. A direct line has been established between each PCCP and the respective S&WB pump stations. Seven of the eight permanent PCCP staff positions have been filled. Additional FPA staff mechanics have been familiarized with PCCP operations in order to provide storm support. The FPA is working with the USACE, CPRA and S&WB to adjust and finalize the settings for the automatic storm mode based on the level of each canal.
- Finance The annual fiscal year financial audit of the FPA begins in July. ADP timekeeping is in place across the FPA. The FPA must select a new investment broker in August since Capital One will no longer provide this service. The Regional

Finance Director will provide recommendations regarding the selection. Purchasing across the FPA has been consolidated. The next phase of payroll consolidation is underway. Grant metrics are under developed in order to make the pursuit of grants more successful.

- Employee Services (HR) The annual Performance Evaluation process will begin in July. Supervisor training is being conducted this month. The consultant's team has new processes in place for Performance Evaluations and recruiting, and is close to finalizing new processes for hiring, orientation and out processing. Mr. Boese noted that the FPA is very close to being able to advertise and fill the position of HR Director. An additional discussion is needed with Civil Service to attempt to upgrade the HR Director position.
- Bellaire Drive Seepage The USACE completed placement of the clay blanket and hydro seeding the area. A small amount of seepage is appearing near the street; however, the amount of seepage has been greatly reduced. The FPA's consultant provided an analysis of the USACE's efforts regarding the seepage. The opinion of the FPA is that a drainage system is likely needed. The collaborative effort between the FPA and the USACE is continuing and the USACE is considering the FPA's consultant's findings.
- Technology Subcommittee Technologies that will be further explored include use of drones, remote monitoring and security enhancements.
- I-STORM FPA staff met to review the I-STORM draft report. The I-STORM report has not yet been finalized.

Mr. Morgan asked, did the completion of the PCCP relieve the FPA of the obligation to maintain the outfall canal levees? Mr. Boese replied that the question has not yet been answered. At this time the FPA is still responsible for maintaining the levees/floodwalls from the lake to the S&WB pump stations.

Mr. Morgan suggested that department directors be given an opportunity to provide a report to the Board.

Mr. Miller discussed the issue brought up earlier in the meeting about the capacity of 17th Street Canal. The volume of water coming from Jefferson Parish, excluding Pump Station No. 6, is a very minimal amount compared to the total capacity of Jefferson Parish. Therefore, the capacities of the pump stations along the lake, as well as the pump station at the parish line in Kenner, far exceed the capacity going into the 17th Street Canal. In addition, the 17th Street Canal has been improved from Pump Station No. 6 to the lakefront in order to handle the additional flows projected from both Orleans and Jefferson Parishes. The designs for the proposed new pump stations in Jefferson Parish have been reviewed and approved. The 17th Street Canal open flow capacity with the gates open far exceeds the additional projected capacity. The 17th Street Canal PCCP pump station can not only handle the additional flow from Pump Station No. 6, but also with the additional flow from Jefferson Parish. He stated that he was very comfortable that the 17th Street Canal will be stable, safe and capable of handling all of the flows going into the canal.

Mr. Miller further explained that the outfall canals were designed for improvement during the PCCP project. The hydraulics were designed with a maximum flow coming in that the pump station can handle, which is more than the volume that Pump Station No. 6 and the existing pump stations pump into the 17th Street Canal. In addition, there is 1-1/2 feet of freeboard for safety purposes. The models and designs are very safe for the 17th Street Canal.

NEW BUSINESS:

RESOLUTION NO. 06-14-18-03 - RECOGNITION OF G. PAUL KEMP

John Barry, former FPA Board member, stated that the statutory responsibility of the FPA is to protect the territory from overflow. It is not specifically operation and maintenance; it is to keep people safe and dry. The FPA's mission statement was defined as a minimum of 500-year protection. The only way to get there involves the coast. He explained that the Board did not initially have a member with coastal expertise; therefore, when a vacancy came up he recruited Mr. Kemp and recommended that he be appointed by the Governor. He stated that when the Board filed the lawsuit (Southeast Louisiana Flood Protection Authority-East, et al. v. Tennessee Gas Pipeline Co., LLC, et al.), Mr. Kemp came under more pressure than any other member of the Board. He was forced to either leave his job or the FPA Board. He recognized Mr. Kemp for the courage and commitment that he showed at that fairly tense time. He commended Mr. Kemp on his continued work on sediment and the Missouri Basin and urged the Board to support Mr. Kemp's work.

Mr. Barry provided an update on recent coastal restoration developments. A Congressional subcommittee, which includes Garrett Graves, is attempting to craft legislation that increases the federal contribution to coastal restoration and simultaneously requires some share to be paid directly by the industry over and above GOMESA. The proposed legislation may not become law; however, the conversation is of value. In addition, a decision was made last month on a small private landowner case that could have significant implications. Federal Court ruled for the first time that a pipeline company had to restore land. It was only 9.6 acres; however, it will probably cost the company ten to fifteen million dollars. The same set of attorneys that was hired by the Board worked on the case. The attorneys sought an injunction requiring the pipeline company to do the restoration. No payment or fee was received by the attorneys from the award. However, if the ruling survives the Fifth Circuit, there will be many more landowner cases during which the attorneys will be seeking a fee.

Mr. Kemp stated that it had been an honor to work with the members of the Board and FPA staff. He commented that the FPA is a top notch organization and that when he visited other storm surge closures with I-STORM members, he realized that the FPA has a system that measures up to any system around the work in terms of risk reduction. He stressed that the FPA must continually strive for improvement. The FPA cannot just do maintenance, but must always be looking for ways to enhance the system. He commented concerning issues where the Board made a significant difference, such as obtaining armoring on all HSDRRS earthen levees, and the continued search for weak links in the system and attempts to make these areas

stronger. He urged that this work continue and that the FPA continues looking at the next level. He stated that he would try to maintain some contact through the Coastal Advisory Committee. He expressed confidence that the Board will live up to expectations and continue making the region safer. He cautioned that if complacency develops, it would be a sign that a new vision is needed. The FPA must continually be bolstering the system and looking at every detail as the Board is currently doing.

Mr. Luettich expressed his appreciation to Mr. Kemp for his service on the Board. He stated that he has been incredibly impressed by Mr. Kemp's knowledge of the natural systems within which the risk reduction system resides. If the FPA just thinks about levees, floodwalls and floodgates without understanding the system within which they reside, it is doomed for failure. He stated that this has been one of Mr. Kemp's true strengths and that he has learned much from Mr. Kemp over the years that they served together on the Board. He commented on Mr. Kemp's compassion. Mr. Kemp is a scientist, but he is also a compassionate person and brings compassion to science.

WHEREAS, Mr. Kemp graduated from Louisiana State University in 1986 with a Ph.D. in Marine Sciences and minor in Geology, and in 1978 with a Masters in Marine Sciences, and Cornell University in 1975 with a B.S. in Natural Resources; and

WHEREAS, Mr. Kemp's over forty years of professional experience and expertise in the field of environmental sciences and geology have provided an invaluable resource for the FPA and its member levee districts during the construction of the over \$14 billion Hurricane and Storm Damage Risk Reduction System; and

WHEREAS, Mr. Kemp's leadership, hard work and devoted service as a member of the Board from August 12, 2011 to June 30, 2018, as Secretary of the FPA from January 21, 2016 to June 30 2018, as Chair of the Coastal Advisory Committee from December 2, 2011 to June 30, 2018, and as a member of the Operations Committee from October 24, 2016 to June 30, 2018 has resulted in many positive achievements and improvements to the flood protection system; and

WHEREAS, recognizing the importance of the mission of the Southeast Louisiana Flood Protection Authority-East, Mr. Kemp has continuously strived to achieve the best flood protection possible and has worked tirelessly in the service of the citizens of Southeast Louisiana.

BE IT HEREBY RESOLVED, that the Southeast Louisiana Flood Protection Authority-East hereby expresses its gratitude and appreciation to Mr. G. Paul Kemp, Ph.D., for his dedication and contribution during his tenure as a member of the Board of Commissioners of the Southeast Louisiana Flood Protection Authority-East.

RESOLUTION NO. 06-14-18-04 - TO DIVEST LAKE BORGNE BASIN LEVEE DISTRICT OF INTERNAL PUMPING AND DRAINAGE FUNCTIONS AND TRANSFER THOSE FUNCTIONS TO ST. BERNARD PARISH

Mr. Latiolais abstained from the discussion and vote on the divestment of LBBLD internal pumping and drainage functions and transfer of those functions to St. Bernard Parish.

Mr. Cosse advised that he met with St. Bernard Parish President Guy McInnis at length. St. Bernard Parish government wants to accept the canals and pump stations; however, there is an issue regarding funding. He asked the origin of the onetime payment stated in the proposed resolution. Mr. Hassinger explained that the onetime payment provided in the resolution represented one-half of the amount budgeted on an annual basis for the operation of the pumps and drainage and one-half of what was identified as deferred capital improvement costs.

Mr. Cosse asked the cost to maintain LBBLD's perimeter system. Mr. Hassinger explained that the maintenance cost for the perimeter system as a whole is in the range of \$20 million. Mr. Luettich pointed out that the cost to maintain LBBLD's perimeter system is approximately \$3.6 million. Mr. Hassinger added that \$3.6 million is 100 percent of the revenues currently collected by the LBBLD.

Mr. Cosse stated that St. Bernard Parish government is earnestly looking at different ways to fund the internal pumping and drainage functions. He stated that he and President McInnis had a problem with the onetime payment and did not think that the onetime payment of \$1.06 million is sufficient. He stated that President McInnis wants to continue to work towards a solution.

Mr. Luettich explained that multiple meetings and on-going discussions have taken place for over a year in an attempt to resolve this issue; however, no progress has been made. It became very clear while putting together the FY 2019 budget that the LBBLD

will become insolvent should action not be taken and that the LBBLD's efforts and funding needed to be prioritized. The proposed resolution essentially provides St. Bernard Parish government one year to determine how to fund the internal pumping and drainage since the FPA is stating that it will continue to own it for the next six months and will provide enough money to pay for the following six months. Basically, it provides a year's worth of funding during the transition, as opposed to just turning over the pumping and drainage responsibilities on July 1, 2018. He added that a better resolution of the issue could be reached between now and January 1st; however, the proposed resolution provides a thoughtful solution that would go into effect on January 1, 2019, should no other resolution of the issue be reached.

Mr. Cosse asked if the one-time payment is a third of the cost for the perimeter system. Mr. Hassinger clarified that it would be close to one-third of what it costs to appropriately operate the perimeter system in the LBBLD.

Mr. Luettich pointed out that the onetime payment would be funded from the LBBLD's fund balance. It would not be coming from the LBBLD's annual millage collection, which matches what is needed to operate and maintain the perimeter system. All internal drainage at this point is being funded from the LBBLD's fund balance, which has been steadily declining. In two years the LBBLD will have a zero fund balance. This action is designed to prevent the LBBLD from having a zero fund balance. He pointed out that one of the LBBLD's millage taxes will expire in two years (2020). If that millage is not renewed or replaced, then the LBBLD will not have enough revenue to fund operation and maintenance of the perimeter system with the current funding formulas. He stressed that an overly rational approach has been taken in dealing with this issue.

Mr. Cosse stated that he disagreed with Mr. Luettich. The FPA governs as a region. St. Bernard Parish has a population of roughly 40,000 people, which accounts for five to six percent of the total population of the region. He stated that the Board cannot expect six percent of the population to pick up 33 percent of the cost.

Mr. Luettich responded that he was not sure that the ratio mentioned by Mr. Cosse was correct. He reiterated that the cost to maintain the entire perimeter system is about \$20 million and that the cost to maintain LBBLD's perimeter system is \$3.6 million, which is about 12 to 15 percent of the cost for the entire system. He advised that funding formulas may change and that an aspect of this action places the FPA in a better position to negotiate a more regional funding formula. Until apples to apples responsibilities are achieved across the parishes, there will be difficulty discussing regionalizing funding and making the approach more equitable.

Mr. Cosse stressed that everyone should pay the same across St. Bernard, Orleans and East Jefferson Parishes.

Mr. Hassinger explained that the suggestion was made earlier that the citizens of Orleans Parish underpay the cost for the maintenance of the perimeter system. The suggestion was also made that the citizens of Orleans Parish should pay 42 percent of the cost of the perimeter defense system. He clarified that the citizens of Orleans Parish currently pay about 60 percent of cost to operate and maintenance the perimeter

defense system. He disagreed with the suggestion that the citizens of Orleans or Jefferson Parishes are not paying enough. He stated that he appreciated the difficulty faced by President McInnis and St. Bernard Parish; however, if the citizens of St. Bernard Parish are paying 15 percent of the cost for the perimeter system, it would be difficult to arrive at a lower figure. The argument has been made that the IHNC Surge Barrier and T-wall that lines the MRGO primarily benefit Orleans and Jefferson Parishes; however, if the Surge Barrier, new Bayou Dupre, Bayou Bienvenue and Caernarvon Complex Structures or the flood defense system that protects St. Bernard Parish were not constructed, then St. Bernard Parish would be left with the Forty Arpent Levee as its primary defense—a nine foot levee compared to a substantial modern defense system that it now enjoys.

Mr. Hassinger added that it is a mistake for people to imply that the part of the perimeter system located in St. Bernard Parish primarily protects Orleans and Jefferson Parishes and that the opposite is true. It is a mistake to minimize the significance of the system in terms of the protection it affords the citizens of St. Bernard Parish. The case was made that because property values are less in St. Bernard Parish and St. Bernard Parish has fewer people, they should pay less and some other measure should be implemented, such as using miles or acres of levee or floodwalls or number of structures. He cautioned that the individuals who were attempting to make this case should be careful about what they are asking because St. Bernard Parish's contribution would increase and not decrease.

Mr. Hassinger explained that with respect to the suggestion that since the FPA has taken responsibility for operating the PCCP, it should also operate the internal pumping system for the LBBLD, there is a distinction because the PCCP at the outfall canals form part of the Hurricane and Storm Damage Risk Reduction System (HSDRRS). Therefore, they are a part of the perimeter defense system. The PCCP are not just pumps; they are closure structures that prevent inundation by the lake into the canals. The idea that the FPA needs to regionalize and become more efficient and act more like a regional authority is like Anheuser-Busch preaching the virtue of abstinence; none of that occurred until the last few years. This is exactly what the FPA has done. The fact that the FPA has become more efficient, centralized and effective as an organization does not mean that the LBBLD can be allowed to go bankrupt. He stressed that the perimeter system, which is the FPA's primary responsibility, must be maintained.

Mr. Kemp stated that in looking where the FPA is headed, the assets located in St. Bernard Parish are probably the focus of the FPA's attention. The FPA has been looking at the internal storage capacity both in the IHNC and Central Wetlands as a method of improving flood defenses beyond the 100-year level. He pointed out that the FPA is bound with restrictions on funding and spending that do not reflect future needs. The FPA has attempted several times to get things done at the Legislature. He urged that time be spent with the Governor before the handoff occurs in order to work through this important issue.

Mr. Miller clarified that between this point and December 31st the FPA would continue operating and maintaining the pumping and drainage system. On January 1, 2019, the pumping and drainage system would be handed over to St. Bernard Parish with

sufficient funding for six months of operation and maintenance, as well as funding for capital improvements. Therefore, the FPA is basically giving a year for a final resolution of the funding to be achieved.

Mr. Luettich reminded everyone that one reason for this action is to place the FPA in a stronger position to potentially engage the Legislature on a more appropriate funding formula for the perimeter system. The pumping and drainage issue has confused and gotten in the way of this achievement. In the longer term, the goal is to have a more equitably funded perimeter system, as well as having St. Bernard Parish Government handle the interior drainage for their parish. Therefore, for the citizens of St. Bernard Parish the goal in the long term is to have a more equitable overall financing of a combination of the interior drainage and the perimeter defense system. He stressed that the action is not just a divesture of the internal pumping and drainage system. The FPA cannot gain any traction on the reconsideration of the perimeter funding formula with the internal pumping and drainage issue in the way.

Mr. Cosse advised that prior to Hurricane Katrina St. Bernard Parish had a dual levee system. It had the nine foot Forty Arpent Levee, a middle ground retention area and a 15-foot levee that failed. St. Bernard Parish had what it thought to be adequate protection. He stated that he was not implying that the citizens of New Orleans and Jefferson Parish are paying too much or not enough. He stated that a formula can be developed to benefit everyone, such as one based on property values. He reiterated that he is only looking for everyone to pay the same and for equity.

Mr. Morgan commented that the FPA has been trying to negotiate the transition of the internal drainage and pumping to St. Bernard Parish for some time. He advised that he was prepared to come to the Board with a much higher financial distribution; however, St. Bernard Parish Government kept asking for more money and the parties could never reach a final resolution that was in the best interest of the FPA. Therefore, the proposed resolution before the Board will transition the internal drainage and pumping, and provide St. Bernard Parish Government with one year to determine a way to operate and maintain their system and/or come forward with a better solution for the FPA to evaluate. The process was taking a lot of energy and focus and going nowhere. Therefore, the proposed resolution puts a plan in place in order to move forward and the internal drainage and pumping will be in the hands of St. Bernard Parish as of January 1, 2019. The FPA can then go back to the Legislature and advise legislators that the FPA is maintaining the perimeter system and a reevaluation is needed regarding how costs are shared and funded.

Mr. Cosse stated that the Legislature created the Flood Protection Authority, and in doing so, combined the three levee districts. He stated that he did not see how the FPA could unload the burden financially on St. Bernard Parish without more than what is currently on the table.

Mr. Hassinger responded that if President McInnis has a number for a little bit more funding, then he should call him. Mr. Cosse responded that he would do so.

Mr. Miller commented that he understood Mr. Cosse's argument, having been involved in Jefferson Parish Public Works, which had multiple drainage, sewerage and water districts each with separate funding, and allocating funding where it was needed became a difficult problem as one district may have had surplus funding and another district needed funding. However, Jefferson Parish Public Works had to deal with this issue since it was not allowed to cross transfer funds. The Legislature has limited to a degree the FPA's ability to allocate funds where needed and made it clear that the FPA cannot spend Orleans Parish tax revenues in Jefferson Parish or Jefferson Parish tax revenues in St. Bernard Parish. However, this is the situation that the FPA must face.

Mr. Kemp stated that the FPA would want to make sure that the negotiating table is expanded for the next phase so that new options can come to light and perhaps State level leadership can help with this issue.

Mr. Hassinger assured the Board that over the next six months the goal is to keep the negotiations open. The Board cannot put the FPA or LBBLD in terms of their obligation to properly manage the perimeter system at risk or in bankruptcy. He clarified that the CPRA has been involved in multiple meetings attempting to help negotiate a solution. Those meetings constitute just a small percentage of the number of meetings overall that have taken place. He stated that he did not want to minimize the position that St. Bernard Parish is in and that he understood the difficulty being faced by St. Bernard Parish. He noted that Windell Curole, General Manager of the South Lafourche Levee District, who is well respected in these matters, put it well when he said that the success of the South Lafourche Levee District is because people have shown the willingness to tax themselves. They have done that and have met with great success enhancing their flood defense system. Taxes have gone up in New Orleans. The FPA tried twice to pass new millages in St. Bernard Parish to cover this cost and failed both times. There is nothing else that the FPA can do at this point. He hoped over the next six months that discussions of possible scenarios will continue and that a solution that is acceptable to everyone can be worked out. The goal is to keep residents of St. Bernard Parish from flooding. Former FPA President Stephen Estopinal said several years ago, the people in St. Bernard Parish are going to experience flooding because there is not enough money generated to maintain the perimeter system to fight against storm surge and maintain the pumps and drainage to protect against rising water from rain events or storms.

On the motion of Mr. Luettich, Seconded by Mr. Morgan, the following resolution was offered:

WHEREAS, pursuant to La. R.S. 38:330.1, the Southeast Louisiana Flood Protection Authority-East ("the Flood Protection Authority") through its board of commissioners, exercises all authority over and has management, oversight, and control of the Orleans Levee District, East Jefferson Levee District and Lake Borgne Basin Levee District; and

WHEREAS, the Flood Protection Authority is authorized under La. R.S. 38:281 et seq., R.S. 38:301, R.S. 38:327, and La. Const. Article VI, Part III to provide for the construction and maintenance of levees, levee drainage, flood protection, and

hurricane flood protection within the territorial jurisdiction of the Flood Protection Authority including on its own behalf or for the areas under its authority; and

WHEREAS, under La. R.S. 38:281 et seq., R.S. 38:301, R.S. 38:327, and La. Const. Article VI, Part III, the construction, maintenance, and care and inspection of levees, within the jurisdiction of the numerous levee districts and levee authorities established by Louisiana law shall devolve on the levee districts and levee authorities and the boards of commissioners of the respective levee districts and levee authorities; and

WHEREAS, unlike the Orleans Levee District and East Jefferson Levee District, the Lake Borgne Basin Levee District currently operates interior drainage pumps and maintains drainage canals in St. Bernard Parish at an annual cost of approximately \$1,385,650; and

WHEREAS, the Flood Protection Authority's primary responsibility is operating and maintaining the perimeter flood defense system, which consists of the Hurricane and Storm Damage Risk Reduction System, Mississippi River Levees and numerous other levees and floodwalls; and

WHEREAS, the portion of that system located in St. Bernard Parish costs approximately \$3.6 million annually to effectively operate and maintain; and

WHEREAS, each year the Flood Protection Authority collects 11.3 mills in St. Bernard Parish property taxes for a total of \$3,627,995, which does not provide sufficient funding to effectively operate and maintain the perimeter flood defense system while also operating the Parish's internal pumping and drainage functions, which include eight pump stations and fifty-six miles of drainage canals; and

WHEREAS, in 2014 and 2015, St. Bernard Parish voters twice rejected millage increases intended to provide the Lake Borgne Basin Levee District with the funding necessary to effectively operate the perimeter flood defense system and perform internal pumping and drainage functions; and

WHEREAS, the Flood Protection Authority cannot continue to effectively operate the perimeter flood defense system while also performing the Parish's internal pumping and drainage functions and, therefore, must divest itself of St. Bernard Parish internal pumping and drainage functions; and

WHEREAS, the other two parishes within the purview of the Flood Protection Authority -- Orleans Parish and Jefferson Parish -- operate their internal pumping and drainage systems with no funding from or management by the Flood Protection Authority; and

WHEREAS, the Flood Protection Authority has, for more than a year, conducted good faith negotiations with St. Bernard Parish to reach a solution by which the Parish would accept responsibility for the Parish's internal pumping and drainage needs; and

WHEREAS, La. R.S. 38:330.2 allows the Flood Protection Authority to divest itself of any internal drainage or pumping responsibilities that would otherwise fall to the responsibility of a parish governing authority; and

WHEREAS, while La. R.S. 38:330.2 does not mandate that the Flood Protection Authority transfer any funds to a parish governing authority when the Authority divests itself of internal pumping and drainage responsibilities, it is in the best interest of the citizens of St. Bernard Parish that the Flood Protection Authority do so in this instance; therefore,

BE IT HEREBY RESOLVED, that the Flood Protection Authority has determined that it cannot continue to effectively operate the perimeter flood defense system while also operating the Parish's internal pumping and drainage functions and, therefore, must divest itself of St. Bernard Parish internal pumping and drainage functions.

BE IT FURTHER RESOLVED, that on <u>January 1, 2019</u>, the Flood Protection Authority shall divest the Lake Borgne Basin Levee District of all pumping and drainage responsibilities, including all pump stations and drainage canals, and transfer those responsibilities to St. Bernard Parish, such that St. Bernard Parish will perform the internal pumping and drainage functions for its citizens, just as Orleans Parish and Jefferson Parish do for their citizens.

BE IT FURTHER RESOLVED, that to assist St. Bernard Parish with this divestiture and transfer, the Flood Protection Authority will, contemporaneous with the divestiture and transfer, make a one-time payment to St. Bernard Parish of **\$1,067,825**, which is approximately one-half of what the Flood Protection Authority has budgeted in FY 2019 for one year of pumping and drainage operations in St. Bernard Parish, plus one-half of what the Flood Protection Authority has calculated in costs related to deferred capital improvements.

BE IT FURTHER RESOLVED, that the Flood Protection Authority President is authorized to execute all documents necessary to accomplish the divestiture, transfer and payment authorized herein.

Mr. Hassinger explained that Mr. Englande, who was unable to attend today's meeting, asked him to communicate to the Board that he had met with Anne Rheams and discussed the program. Mr. Englande is involved in and highly supports the program, and hoped that the Board approves the contract.

Mr. Boese advised that the contract with Water Management Communications that expires on June 30, 2018, was for a not to exceed amount of \$100,000. The proposed contract is for an amount that is significantly less than the expiring contract because the FPA is in the process of hiring a Public Information Director. Some money is included in the proposed contract for continued support during the transition period and as needed; however, the vast amount of the money is for educational outreach to expand the current program in St. Bernard Parish to Orleans and Jefferson Parishes and for the creation of videos to expand the FPA's educational outreach.

On the motion of Mr. Luettich, Seconded by Mr. Morgan, the following resolution was offered:

WHEREAS, the Southeast Louisiana Flood Protection Authority-East (FPA) utilized the services of Water Management Communications for a period commencing on October 24, 2016 through June 30, 2018, for the development and implementation of an Education and Public Outreach Program for the FPA; and

WHEREAS, the Authority desires to continue the development and implementation of the Education and Public Outreach Program and received a Scope of Services for the period July 1, 2018 through June 30, 2019 that includes costs for the services of Water Management Communications, as well as the associated professional services needed for the development and implementation of the program, and to provide on call back up media assistance with a total not-to-exceed amount of \$65,000.

BE IT HEREBY RESOLVED, that the Southeast Louisiana Flood Protection Authority-East authorizes the FPA Chief Administrative Officer to execute a Professional Services Agreement with Water Management Communications with a total not-to-exceed amount of \$65,000 to continue the development and implementation of the Education and Public Outreach Program and to provide on call back up media assistance for the period of July 1, 2018 through June 30, 2019.

WHEREAS, the U.S. Army Corps of Engineers ("Corps") and the Coastal Protection and Restoration Authority Board ("CPRA Board") executed the Project Partnership Agreement ("PPA") for the Lake Pontchartrain and Vicinity, St. Bernard Parish, Louisiana, Hurricane Protection Project ("LPV") on September 22, 2008. The CPRA Board signed the PPA as Non-Federal Sponsor for LPV; and

WHEREAS, Article III of the PPA requires the CPRA Board to acquire property rights on alignments approved by the Corps that the Corps determines are needed for construction, operation, and maintenance of LPV, and to provide the Corps with authorization for entry thereto; and

WHEREAS, by authorization dated March 19, 2009, CPRA Board Chairman Garret Graves authorized Orleans Levee District ("OLD") to acquire and grant authorizations for entry to the Corps for property rights required for construction, operation, and maintenance of LPV; and

WHEREAS, by letters dated April 11, 2016, September 19, 2016, February 16, 2017, October 23, 2017, and January 31, 2018, the Corps issued Right of Entry Requests ("ROE Requests") to the CPRA Board and the Southeast Louisiana Flood Protection Authority-East for the Lake Pontchartrain and Vicinity (LPV), LPV-ARM-09 System Armoring (LPV 111.01, New Orleans Back Levee, CSX Railroad to Michoud Canal Baseline Station 1061+30 to 1341+70), Orleans Parish project (the "Project"). The Project is part of LPV, and the ROE Requests identified the alignment for the Project approved by the Corps; and

WHEREAS, OLD is acquiring the property rights required in the ROE Requests that are outside of its existing right of way. Coastal Protection and Restoration Authority ("CPRA"), the implementation and enforcement arm of the CPRA Board, is paying the acquisition costs for these property rights; and

WHEREAS, the property rights required by the Corps for the Project include a temporary work area servitude over property identified as Parcel Nos. 7-3 and 7-4 and a temporary access servitude over property identified as Parcel Nos. 12-1, 12-2, 13-1, and 14-2 ("Servitudes"). These six parcels are owned by Harvey Canal Holdings II, LLC ("Harvey"); and

There was no further business; therefore, the meeting was adjourned at 12:55 p.m.

I'd like your indulgence while I address an issue we have been dealing with for quite a while now.

Before I was appointed to this board, there was a desire to rid ourselves of the responsibility for drainage in St. Bernard Parish. I understand the motivation is primarily that we don't feel that there is enough tax revenue generated in the Lake Borgne Basin Levee District to adequately do both perimeter maintenance AND handle drainage.

We all know that the Netherlands is used as the "gold standard" for flood protection. Under one umbrella organization, the Dutch handle drainage, levees, ground water, land recovery and other related responsibilities. For us to abandon the notion that all of these interests should reside under one authority is counterintuitive. Furthermore, we have recently agreed, in the aftermath of a recent flood event, to take on the operations and maintenance of the pump stations at the three Outfall Canals. As much as I believe we should strive to coordinate all issues of flood protection under a single umbrella, I think that St. Bernard drainage remaining the responsibility of the Authority is "a horse already out of the barn".

If my belief is correct, and we do relinquish drainage in St. Bernard, then the only responsibility we will have in the Lake Borgne Basin Levee District is the Operations and Maintenance of the perimeter system. Operations and Maintenance of the perimeter is often cited as our only purpose. Our purpose should be much broader than operations and maintenance of a system. We were created, in the aftermath of Katrina, as a consolidated levee board. The watchdog group, Bureau of Governmental Research reported that "...the New Orleans region's fragmented system of flood control and hurricane protection contributed to the deadly flooding and widespread destruction during Hurricane Katrina." Although I hope that we will push for higher levels of protection, as to operations and maintenance of the perimeter system, we cannot revert back to a "fragmented system of flood control".

Our intent and mandate, CLEARLY, is to approach flood protection as a Regional Authority. That is what the voters were told they were getting - a REGIONAL AUTHORITY and all that it implies. We must apply the same rigorous standards throughout the region, not diminished standards based on an arcane understanding of spending restrictions. Just as the National Flood Insurance Program sets rates based upon elevation and levee protection, charging the same rates, NOT DISPARATE RATES, to businesses and homeowners within the same flood zone, WE should spread the cost of Operations and Maintenance equally among ALL who live within, and share the benefit of, the SYSTEM. We have to remember that this is a system and must treat it accordingly. If a portion of the system fails because of a lack of coordinated effort, funding and maintenance, we will have failed as a board. We must make continued efforts to streamline costs, combining job responsibilities rather than continuing duplicative services at each independent Levee District. I don't think that any of us wants the Authority to become another inefficient governmental entity. If we continue to operate in this manner we will have failed the voters, we will have failed as an Authority and should admit failure and petition the legislature to reinstate the prior levee boards. That is not what I want and I know that it isn't what any of you want.

How do we act regionally? We share the costs of the system — Operations and Maintenance, Levee Lifts, armoring, life cycle maintenance — fairly and equitably throughout the system. We all agree as scientists, board members, engineers etc. — This system is built to protect property NOT people. Our taxing districts collect taxes based upon property assessments. The value of all property within the system is \$5.5 billion. All of that property is protected by the system. When the system is recertified it will be recertified as a system. If recertified, it will be accredited by FEMA — as a system. If it is not recertified as a system ALL of the property within the entire system will suffer the same fate — exponentially increased flood insurance rates — for EVERYONE and every piece of property inside of the SYSTEM!

Since property assessments are the majority of the taxes we collect, the operations and maintenance costs should be apportioned the same way. The math is very easy. The assessed value of the property inside of the system - \$5.5 billion – is the denominator. The numerator is the amount of assessed value within each taxing authority. As an example, the value of the property in Orleans Parish is \$2.3 billion. \$2.3 billion divided by \$5.5 billion = 42%. The cost of the O&M of the perimeter system should be borne 42% by the taxes generated in Orleans Parish. The same math applies throughout the system. If we assign costs any other way we might potentially be charging the owner of a \$1 million piece of property \$1,000 while a similarly assessed business located in a different parish, just a block away, would be charged \$100. This makes no common sense, is counterintuitive and NOT REGIONAL.

Using this rational, the assignment of costs to St. Bernard/Lake Borgne Basin Levee District should be \$328 million (assessed value of the property inside of St. Bernard Parish) divided by \$5.5 billion = 6%. That is the amount of the Operations and Maintenance costs that should be assigned to Lake Borgne Basin Levee District — no more. If the O&M of the SYSTEM costs \$15 mil LBBLD should pay 6% of that total — or \$900,000 (\$15,000,000x6%=\$900,000). Taxes collected over and above this amount should be turned over to St. Bernard Parish and used to pay for the responsibility of drainage in St. Bernard. If we give them less we are putting a portion of the REGION in jeopardy of flooding. This is untenable, counter to our mandate of protecting the region from flooding, and an act, which we as a board should not permit.

Arguments of law against sharing the costs of operating and maintain the system as I propose are illogical, political arguments which have no true legal basis. Revised Statute 38:330 CLEARLY allows for cost sharing in the mutual interest of contiguous levee districts. Memos have been written by the Attorney General's office supporting this legal argument. Numerous studies suggest equitably sharing the O&M costs throughout the districts under our authority. Even if none of this were true, and it all is, we should assign the costs based upon assessed values and return any

additional tax collections to St. Bernard because that is the ONLY way for us to live up to our mandate. If we give less than that to St. Bernard we are shirking our mandate to protect the region from flooding.

I would like to follow this with the offer of a motion.
