#### Keepin' Your Head Above Water



Middle School Science Curriculum

Teaching students about the Hurricane and Storm Damage Risk Reduction System (HSDRRS) will help future generations understand its importance and share this information with their families and friends. This education program targets public and private middle school science classes in the Flood Protection Authority's regional jurisdiction of St. Bernard, Orleans and East Jefferson Parishes.

The middle school science program educates through the originally-developed curriculum, *Keepin' Your Head Above Water: Know Your Flood Protection System.* The curriculum includes lessons and activities on geographical orientation (where do I live and where is the water), the Flood Protection Authority's flood protection system (where is it and what is it) and ways students can reduce risk related to tropical storms and hurricanes for their families and homes.

The curriculum guide will be available for teachers on the Flood Protection Authority's website before the beginning of the new school year.

# **Reporting Critical Information**

Items of this nature are important enough employees need to notify their supervisors immediately and the chain of command notifies me by text/phone call/in person immediately or as soon as practically possible; or if the chain of command cannot be reached they contact OLD Dispatch (504-283-9800, manned 24/7) who then contacts me.

- Any employee injury requiring medical attention
- Any vehicle/equipment/property damage requiring a police report
- Any incident resulting in injury to a 3<sup>rd</sup> party or damage to a 3<sup>rd</sup> party property
- Any police incident involving Use of Force
- Any complaint against an employee involving ethics, malfeasance, harassment or similar issues; or criminal behavior
- Any altercation between an employee and another individual (another employee, private citizen, etc.)
- Any loss of data or money
- Any damage to the system resulting from major incident such as vehicle strike, ship/vessel strike, fire
- Any seepage, sand boil, slump or other serious issue
- Storm Season: Any loss in capacity (pump station) or inability to operate (complex structure/floodgate) that cannot be repaired within 6 hours
- Non-Storm Season: Any loss in capacity (pump station) or inability to operate (complex structure/ floodgate) that cannot be repaired within 24 hours
- Any media inquiry involving any of the above topics

Chandra is available to provide support and referral services for employees and families who are experiencing acute stress due to crises including natural disasters, terror attacks, or personal grief and loss. Chandra is certified in Professional Disaster Mental Health Training, a certification only available to those currently licensed as mental health professionals (B.S. in Psychology and an M.A. in Mental Health Counseling). This position does not provide therapy to employees, but serves as a source of support and a resource for referrals.

# Police Wellness Program Coming This Fall!

In preparation for the upcoming Voluntary Wellness / Fitness Program for all O.L.D. / EJ Officers which will start in the fall, Lacey Gerhold, Mike Brenckle, Pat Conaghan, Terry Durning, Gerald Holmes and Vincent Yetta attended a Fitness introductory Trainer's Course in New Orleans recently.

Participation in this course was designed to teach the attendees how to organize a physical fitness / wellness program for our police Officers.

Our officers in attendance received training concerning the following topics.

- 1. Documentation from a physician prior to engaging in any physical activity.
- 2. Proper diet
  - a. Complex carbohydrates for energy and exercise
  - b. Proper hydration during physical exertion
  - c. Avoiding sugar and saturated fats
- 3. Proper body mass index (BMI)
- 4. Exercises performed in the workplace
  - a. Push ups
  - b. Plank, ab exercise
  - c. Squats
- 5. Genetic predisposition and prevention
  - a. Heart attacks
  - b. Strokes
  - c. Diabetes
- 6. A gym / work out area sanctioned by the Authority at O.L.D. -Franklin Base and the EJ Safe House
- 7. Increased longevity of life and wellness

Based on contemporary fitness training methods, the Authority fitness course will consist of Cardio-vascular / Dynamic Strength exercises for the upper and lower body, flexibility and a mandatory physical assessment testing program based on national norms and fitness standards. The standards will be based on age and sex.

Although the wellness / fitness program for the Police is voluntary, we strongly encourage every officer to participate in it.

Participation will allow each officer to earn a fitness uniform pin and other incentives to be determined. The Authority is also looking for other ways to encourage health and fitness for ALL employees, including expanding this program beyond the police.

# Some Lessons on Leadership from Abraham Lincoln

- Seek causal contact with subordinates. It is as meaningful as formal gatherings, if not more so.
- Everyone likes a compliment.
- Use force only as a last resort.

- Delegate authority and responsibility by empowering people to act on their own.
- A good leader avoids issuing orders, preferring instead to request, imply, or make suggestions.

#### FPA First Aid Classes

First Aid classes being conducted for Flood Protection Authority team members include more than just basic first aid. This vitally important training can help save a life. The classes, which are being held on available Mondays, are being conducted by Tammy Canfield. Tammy is a Police Officer 2 at the O.L.D. and has been a member of the FPA team almost four years. Tammy was certified through the American Heart Association and holds the certification of Basic Life Support Instructor. Tammy's certification covers basic life support and first aid.

Tammy explained the advantage of the new CPR (dummies) equipment being used. The new CPR mannequins have two feedback devices, which will become mandatory in January, 2019. They have a light sequence on the shoulder, which allows visual student feedback. The lights turn red, yellow, and green allowing students to visually see if they are doing compressions at the proper depth and speed. The red light means the chest compressions are not being done properly. The yellow means the student is doing the compressions properly but needs to increase the number of compressions. The green means the student is doing proper chest compressions. The second feedback device is a clicking sound, which allows students an audible form of feedback. The clicking is heard when a student is providing chest compressions at the proper depth. The new equipment is more modern and very lightweight. The mannequins are much easier and more convenient to put together and break down.

To date, five classes have been conducted primarily comprised of supervisors and foremen. Each class can accommodate up to eight participants. Future classes will be scheduled basically by department with registration being made available to all interested team members. The goal of the FPA is to make this training available to all interested employees by end of the year.

Participation in classes also provides an opportunity for team members to demonstrate their acting skills as first aid techniques are practiced.

# Levee District Police Officers Making a Difference

#### **Officers Save Child**

On Thursday, June 21, 2018 at approximately 1436 hours Officer Scott Meunier and Sergeant Michael Schindler overheard a radio broadcast via police radio of a medical emergency located at 510 Monticello Avenue. The dispatcher advised that two juveniles had just been found drowning and pulled from a pool at the aforementioned location.

The EJLD officers arrived within minutes and located a two year old female lying naked and in a supine position next to a pool at the apartment complex. The child was unconscious and not responding, but she was breathing ever so slightly. The officers performed life saving efforts on the child and kept her in a recovery position where she expelled water from her mouth and regurgitated. Although the child was breathing, she would not wake up despite every effort by officers. JPSO

child was breathing, she would not wake up despite every effort by officers. JPSO deputies and fire personnel arrived a short time later to assist. A second child, the first victim's twin sister, was located in the apartment and she was breathing, conscious and alert.

The officers recognized that the child was in desperate need of immediate medical treatment and elected not to await the arrival of an ambulance. The officers along with JPSO deputies and fire personnel loaded the child into a patrol unit and the assisting officers provided an escort to Ochsner Hospital's Emergency Room. The second child was later transported by ambulance to the hospital for follow up care.

Levee District Senior Officers Graduate from First National Command and Staff College for Leadership and Excellence
