Orleans Levee District Police Department Returns to its Historic pre-Katrina Site

The Orleans Levee District's Police staff expressed excitement about moving into the newly constructed facility located on the corner of Elysian Fields Avenue and Lakeshore Drive.

The new 10,000 sq. ft. complex includes a 7,500 sq. ft. police station, storage garage for police vehicles, and security fencing. The facility includes a conference/training room, dispatch/



communications, administrative offices, reception area, holding cell, breakroom, locker rooms and full generation power. The total construction cost for the new Police Complex was \$3,185,579.


Teaming Up to Remove River Debris From the MRL

Seven Leadership Lies and Why They Aren't True

When assessing the qualities of a true leader, we need to separate myth from truth. The following was excerpted from a short article by Mark Sanborn, a bestselling and acclaimed leadership keynote speaker, and provides valuable information on true leadership:

We live in an age that seeks quick fixes and easy answers. Sometimes leaders abdicate their thinking to others and accept "prevailing wisdom," which is often an oxymoron. I grew up, like most, accepting many things at face value. It wasn't until I started giving important issues like leadership a second and third thought that I realized I'd been believing what turned out to be some serious leadership myths. Here are seven leadership lies and why they simply aren't true:

- 1) "All managers are leaders." Truth: Some managers can lead and others don't or cannot. Management is a subset of leadership, not its equivalent.
- 2) "Some are born leaders." Truth: Even someone with a predisposition to lead must learn the skills of leadership.
- 3) "Leaders always have the right answers." Truth: Leaders ask the right questions and know where to find the best answers.
- 4) "You need a title to lead." Truth: To lead you only need to know when it is appropriate to do so and how to do it.
- 5) "Leaders are focused." Truth: Leaders create a shared focus.
- 6) "Leadership is about ambition." Truth: Leadership is about the greater good.
- 7) "Anyone can lead." Truth: Nobody can lead if they lack the desire to do so.

FPA Maintenance Team - Always on the Job

Placing Barriers to prevent traffic issues on Lakeshore Drive near UNO

The duties of the Levee Maintenance Crew can vary depending on seasonal requirements and other factors; however, the Crew is also sensitive to public safety concerns and provides assistance whenever possible. When it was noted that eastbound traffic on Lakeshore Drive was straying into oncoming traffic near Elysian Fields Avenue, the Levee Maintenance Crew stepped up and installed Type III Barriers to significantly improve traffic safety. The use of sand bags has kept the barriers upright for months and demonstrates the kind of attention to detail that come naturally to the group.











Maintenance along the Outfall Canals

In New Orleans, sometimes it seems like the grass and the weeds never stop growing. The Levee Maintenance Crew has to keep up with maintenance needs, even in the narrow confines along the London Avenue Canal. Sometimes, the narrow space and a steep levee add to the challenge. While the OLD Police Department readied itself for the Ribbon Cutting Ceremony on December 13th for the newly constructed modern Police Complex, the **old** O.L.D. Loft Building at the Franklin Complex, which housed the department after the Police Station on Elysian Fields Avenue was devastated by Hurricane Katrina, was being demolished.





In mid-October of 2017, the OLDPD moved to its interim offices at the Lake Vista Community Center until the new police complex could be completed and the department was able to move back to its pre-Katrina site located at the intersection of Elysian Fields Avenue and Lakeshore Drive.

The O.L.D. FPA Team Member Selected to Participate in CPTP Professional Trainer Certificate Program

Chandra Chaffin has been selected as a candidate in the CPTP Professional Trainer Certificate program to begin in January, 2019. The Comprehensive Public Training Program (CPTP) was established by the legislature in 1979 to upgrade professional, technical and managerial skills of state employees. In May, 2018, CPTP unveiled its updated Professional Trainer Certificate program, which was designed to create an opportunity for state employees to master the skills of instructional design and facilitation of programs for their agencies and stakeholders. The goal of the program is to create a community of talent development specialists equipped to help state agencies with the rapidly changing needs of their employees.



The program guides participants through a series of instructor-led and web-based courses to cultivate the skills necessary to design, develop, and facilitate effective training programs. Participants are required to complete all courses and assignments to mastery and participate in online discussions. All work submitted must be original or properly cited work. The program concludes with a capstone where candidates give an original presentation and be interviewed by State Civil Service Talent Development Staff about their design choices. Candidates must reach mastery on the Capstone to receive certification.

New features that enhances the quality of the program include a cohort model of nine candidates who progress through the program together, ongoing interaction and networking, online discussions, and continual feedback to reinforce course content. Candidates must complete the program within a two-year timeframe, but can complete the program in as little as fourteen months.

Chandra is a member of the Finance team and serves as the FPA's Grants Administrator. Due to her educational background and experience, Chandra was appointed to serve as the FPA's Employee Assistance Liaison and Resource/Bereavement Officer and provides support and referral services to the Authority's employees and their families. Chandra is a National Certified Counselor with a B.S. in Psychology and a M.A. in Mental Health Counseling. She is also a member of the Louisiana Counseling Association.

Chandra also served as a member of the FPA's Culture Change Initiative Committee. She takes great pleasure in finding ways to inspire and advance all members of the FPA team and improve workplace environments.

Chandra earned the professional credential of Certified Grant Writer from the American Grant Writers' Association on August 13, 2016, after attending an intensive hands-on five day workshop and passing a seven hour rigorous exam.
