



To Whom it may concern:

I had both a positive and negative experience with Orleans Parish. On Monday the 14th of January I went to the Seabrook Bridge boat ramp to run my boat that I just gotten out of the repair shop. My intentions were to leave it on the trailer and run the engine and return it to the warehouse where it is stored. When I backed down the ramp my trailer dropped and fell into a (hole) or some type of underwater condition. The hole was under water so I was unable to see or avoid it.

In the process of trying to get up and off the ramp I only could go further in the water and get a running start. After several attempts I was able to get out, but in the process I damaged both my truck and boat.

I tried to use the 311 City information desk and was transferred four times and finally spoke to 911. They assured me that I would receive an email and a phone call and I have received neither.

On the 15th after many more phone calls I finally spoke to Lieutenant Mason. He assured me that he would look into the matter. Later I received a phone call from Officer Gray who said she was at my front door. She drove me to where my boat and truck were stored. I showed her the boat and truck and she drove me back to my house. Here is where the true difference was experienced. When we first met she listened with great empathy and ask questions that helped me to explain my ordeal. During the ride she continued to try to understand my horrible experience and was able to relieve my frustration with the process. When we reached my house she spent more time to insure me that I would be OK and that she was going to write up the incident and continue to be available if needed. My words cannot express the peace of mind I had when she drove off.

I would just like to say one more time that I easily could have lost my truck and boat on the ramp. I felt after trying to reach someone from 311 I would never get this resolved. Due to the professional effort of Lieutenant Mason and Officer Gray, I now feel that someone truly cares about serving the people of our city. You always hear the negatives about Officers who serve the people but seldom do you hear the positives. I am now an advocate of the Levee board and its professional personnel.



I never expected to have to say my last goodbyes to my loved ones. I remember being terrified when the doctors said I wouldn't survive through the night if they didn't put me in an induced coma. 

FPA Uses Drone Technology to Advance Mission



In December twenty-three employees participated in a two-part drone training with instructor Malay Ghose Harja, Ph.D., an associate professor from the University of New Orleans. According to the Federal Aviation Administration (FAA) usage in the United States will reach more than 7 million people by 2020 with half of those being recreational users. Currently 8% of the population in America owns a drone and more than 20,000 of those are registered for commercial usage.









"The first step to using a drone for commercial use is to make sure our employees understand the fundamentals and core processes of a drone," said CAO Derek Boese. "This is an excellent opportunity for the Flood Authority to use the latest technology to help us do our jobs more efficiently and provide accurate information to those involved with various projects."

In order to become a licensed drone pilot, an individual must take and pass the test administered by the FAA. "A score of 60 is considered passing, though applicants should strive for the highest possible score. This shows how adequately they know the material and their knowledge of basic airport and airfield operations," Harja added. If an applicant fails the test, it can be retaken 30 days after the initial test date. The multiple choice test will present a wide variety of challenges to the applicant as it will explore several areas of aviation. Public Information Director, Antwan Harris, said, "The most challenging and rewarding part was learning how to read an aviation map. I'd never seen anything like it before, but once you understand the material, it's like reading any other map. The important thing is to constantly study the various materials and not get hung up on one section."

Drones are now becoming common place for many businesses such as online retail giant Amazon. Field crews at Amazon are currently in the test phase with drone deliveries, but less than half of Americans (47 percent) say they're interested in deliveries using the technology according to a new study by technology company ReportLinker. Consumer concerns over drone delivery stems from their privacy and security concerns. According to the report, if drone delivery becomes available, consumers will be most interested in using it to deliver clothes and apparel (27 percent) and electronics (14 percent).





Several survey companies have now been using drones as a means for inspections by the use of thermo-infrared cameras. This technology allows for a drone pilot to see issues such as seepage, property damage from water, and various problems that may be missed by the human eye. The drone industry is currently a \$13B industry and is expected to reach \$90B by 2025 according to Consumer Reports.

Franklin Facility Renovations Update



Construction of Phase I of the Franklin Facility Renovation Project is progressing. Concrete masonry unit (CMU) walls and the HVAC equipment are being installed by the Contractor in warehouse portion of project.

The DIRTT walls (module walls for offices) are anticipated to be delivered in mid-February for Phase II (Administration Bldg.).

Phase I is expected to be completed the first week of April, at which time staff will be moved into the new offices in the warehouse buildout and out of the Administration Building so that Phase II can begin. Phase II is expected to begin in mid-April and extend through the end of July.



Bad Password Behaviors Compromise Security



Security specialists at Proofpoint report that despite the increase in criminal activity in the areas hacking and identity theft, users continue using weak, easily compromised passwords. Proofpoint warns that bad passwords are a gateway to account compromise, but users continue to opt for easy to remember options rather than creating strong, unique credentials. Some bad passwords show users' misguided attempts to add complexity, such as, the seemingly complicated "!@#\$%^&*" is simply the shift key held over the numbers 1 through 8 on a standard keyboard.

Proofpoint cautions that a weak password may technically comply with password composition policies, giving users a false sense of security. Users might create passwords that may slow down a human attacker; however, the real threat are computers. Scrambled passwords may require many guesses for a human to crack, but a computer program can make millions or billions of guesses in a few hours. Therefore, passwords need to be difficult for a computer to figure out!

A new article by a group of password researchers from Carnegie Mellon University (CMU) recommend three tips for creating strong passwords:

- 1. Use at least 12 characters, with at least two or three different types of characters in unpredictable places. Don't put your capital letters at the beginning or your digits or symbols at the end.
- 2. Avoid including personal information, such as birth dates or the names of people, pets or sports teams. Also avoid song lyrics, patterns, and common phrases, they advise, "especially anything related to 'love' in any language."
- 3. **Make something new**: Create a sentence that no one's ever said before and use the first letter or two of each word as your password, mixing in other types of characters.

The researchers also strongly caution against password reuse and advise users to implement two-factor authentication on accounts when it's available.

CUM researchers suggest that to make strong passwords user friendly and less burdensome, that users utilize a password manager, which can generate and store a different, scientifically strong password for each of your accounts.

EJLD Safehouse-Consolidated Facility Nears Completion



Construction of the new EJLD consolidated facility should be completed by March 1st. The contractor and FPA will then address the punch list items. Furniture delivery will take place in February. Staff can expect to move into the new facility sometime in March. The overall wayfinding signage will be installed in four to six months.
