East Jefferson Levee District Safe Room and Consolidated Facility Ribbon Cutting Ceremony Set for March 21st





Going Beyond the Call of Duty

Protect Yourself Against Cybersecurity Threats

Be Aware of Email Spoofing

Recently, the FPA has been bombarded with spoofed emails from scammers. The tactic of the scammers is to forge the sender address, so that an email looks like it's from a legitimate person or organization, in the hopes that you'll open the email and take a certain action. The end goal is to gain access to your personal information, get you to wire money or hand over your financial/user credentials, make you visit a malicious website, or to deliver malware. The delivery of malware not only impacts your local machine, it also impacts the entire network. It's imperative for our (FPA) user community to exercise extreme caution, when receiving and/or opening email correspondences.

Remember to use the same extreme caution when receiving and/or opening email on your personal computer at home in order to protect your personal and confidential information and your computer system.





In response to increasing cybersecurity risks, Information Technology has implemented and is enforcing a new email authentication policy/process. This process is called Multi/Two-Factor Authentication or 2FA. Multi-factor authentication is an authentication method in which a computer user is granted access only after successfully presenting two or more pieces of evidence to an authentication mechanism. This practice is commonly enforced through email and banking platforms. Essentially, 2FA is an extra layer of protection used to ensure the security of online accounts beyond just username and password. In addition, the FPA will enforce a password policy that provides a default password and will subsequently ask you to create a unique password meeting the FPA's complexity standard. This standard will include a minimum of 10 characters with a combination of upper case, lower case, numbers and/or special characters. The frequency of change will be every 45 days.

Operations Employee of the Month

Frank Alfonso was nominated by his colleagues and selected at the Operations Employee of the Month. Frank is a Mechanic 3 in the Mechanic Shop at the Franklin Facility.

Since he started on July 7, 2017, Frank has maintained a steady course. He is always at work, he arrives to work on time, in uniform and ready to start the day. Frank works very well with his peers, he is always ready to help his coworkers with any task. Frank is very efficient in his work and completes assigned tasks in a timely manner. Frank is also very dependable.

Frank demonstrated his teamwork shortly after he started work with the FPA during preparations for hurricane Nate in October of 2017. During this time, Frank was part of the team of mechanics tasked with the removal of the Guard

I-STORM Co-Founder Visits FPA Board



Marc Walraven, M.Sc., Senior Advisor on storm surge barriers for the Ministry of Infrastructure and Environment, the Netherlands, and a cofounder of I-STORM, visited the FPA and provided an informative presentation at the February 21st Board Meeting on the history of storm surge barriers in the Netherlands and on the I-STORM network. President Hassinger in his introduction identified Mr. Walraven as one of the most recognized experts in the world on storm surge barriers and as a colleague and good friend of the FPA. The Netherlands has six storm surge barriers with no two barriers being alike.

Mr. Walraven visited New Orleans on his way to Galveston, Texas, which is faced with the challenge of building storm surge barriers for Galveston Bay, to assist with their flood protection needs. I-STORM is

also planning a workshop that will be held in Galveston in March so that its members can share knowledge and expertise on storm surge barriers in order to assist Galveston with its decision making process.

Mr. Walraven explained that knowledge, experience and expertise on storm surge barriers is a rare and valuable commodity, and is becoming increasingly valuable to governments and entities worldwide looking to construct barriers to protect against flooding due to climate change and changing weather patterns.

Mr. Walraven recounted a meeting in which he and Andy Batchelor, Manager of the Thames Barrier in London, while sharing experiences on storm surge barriers realized the value their knowledge exchange, and in 2006 I-STORM (the International Network of Storm Surge Barriers) was born.

Officer Meunier has proven himself to be a valued part of the EJLD team. He shows up to work on time, every day. He is knowledgeable and readily shares that knowledge with his fellow officers. He is quick to take on any task asked of him and offers assistance to other officers without hesitation. He regularly assists other agencies as needed. With regards to statistics he is routinely the highest producing officer on D-Shift. His proactive productivity is unmatched by anyone on the shift. He meets and exceeds all expectations of an officer. Officer Meunier is quick to act when assisting fellow EJLD Officers and other agencies.

On Saturday, January 26, 2019 Officer Meunier was quick to respond to a vehicle pursuit in progress on two separate occasions. The first was initiated by Louisiana State Police which resulted in a vehicle crash in the 1500 block of David Drive. Three suspects fled on foot into the neighborhood. With the assistance of Officer Meunier two suspects were quickly apprehended and the third, a short time later. A large amount of narcotics and two hand guns were also located in the vehicle.

The second pursuit was initiated by the Harahan Police Department and began on Jefferson Highway. HPD officers were chasing the vehicle after it fled from a traffic stop. During the pursuit, HPD officers reported shots being fired from the vehicle. The vehicle became blocked in by traffic on Jefferson at Little Farms where Officers tactically approached the vehicle and the driver began physically fighting with the officers. Officer Meunier, being the first back up unit on scene, proceeded to the passenger side of the vehicle and deployed his Taser, which was only partially effective. After a brief struggle the subject was taken into custody. It is due to Officer Meunier's quick response and actions that no serious injuries were sustained by either the Officers or the suspect.

Improvements to the Franklin Complex Mechanic Shop



In the last couple of months, the improvements to the Mechanic Shop included the installation of two new 8-foot Patterson ceiling fans and the installation of a new Gardner Denver shop air compressor. Both of these additions to the shop will help improve production efforts, save energy, and will also help improve working conditions on the shop floor. We thank the FPA Board of Commissioners for approving these items under the FY2019 budget. Thanks are also in order to our Purchasing Department for the work they did in the process of purchasing the equipment.

The two new Patterson ceiling fans, one of them pictured left, are mounted to the steel girders above the shop floor. In the winter, they help spread the heat from the overhead gas heaters and in the summer they will create enough air circulation to lower the overall ambient temperature on the shop floor for increased comfort.

The new Gardner Denver shop air compressor, pictured right, is rated at 130 psi, which is a big improvement from the old compressor which only had a maximum output air pressure of 110 psi. Now all of our pneumatic equipment, like our grease pumps, fluid pumps, the tire machine and our air tools, operate at maximum efficiency. Since this new compressor does not run continuously as the old compressor did, it will save energy, in addition to being much quieter during operation.

The renovations to the warehouse building at the Franklin Avenue Administrative Complex are progressing.



The facility consolidates the Administrative, Police and Maintenance functions and for the first time provides in-house safe housing for team members who remain on duty during tropical storms.

The Lakefront Levee poses challenges to the Levee Maintenance Crew. There is vehicular traffic and pedestrian traffic involved, making safety the most important part of the work. The protected side of the levee has been reinforced with geotextile (HPTRM), so the fabric Levee Maintenance Crew needs to different tractors with a higher cutting blade so the reinforcement doesn't get damaged – sometimes it may seem dry to our neighbors, but it's too wet to risk damaging the fabric. This is easily the most public place in which the Crew operates, so a good relationship with our neighbors is important.

In remote areas or areas with minimal access, it's easier to apply herbicide to maintain the levee. The Levee Maintenance Crew must know when weather conditions allow herbicide application. Too much wind or rain, and the herbicide application either will not work or is unsafe. It's just another day of solid work for the Levee Maintenance Crew.



LA State Civil Service Reorganization

Civil Service Implements PODS Model

Effective March 11, 2019, State Civil Service (SCS) implemented its new model for delivering consultative services to state agencies — the PODS model — Proactively Optimizing and Delivering Strategic solutions, aimed at better serving the needs of state agencies. The PODS will consist of teams of SCS professionals who will dedicate their efforts to a small group of assigned state agencies to learn each agency's individual mission, vision, goals and workplace culture. PODS will directly collaborate with state agency leaders and human resources directors to provide support and guidance on routine civil service matters and proactive solutions to critical workforce needs, challenges and opportunities.

Under this new model of delivery, SCS will abolish the Employee Relations, Staffing and Compensation Divisions. The PODS will perform the duties of the former divisions in a single integrated unit, thereby eliminating division silos and striving for direct tailored consultation for each state agency.

SCS created four PODS that will each be headed by an Agency Relationship Manager (ARM). ARMs will be responsible for building and maintaining relationships with key stakeholders: agency leaders and human resources directors. The SCS Chief Operating Officer, Brandy Malatesta, will oversee the operations of the PODS Model and directly supervise the ARMs. Levee districts are assigned to POD-D (Units of Local Government). This is the easiest and quickest way to receive a response.

It's important to note, after submission, that a 2-hour response window should be allowed for all requests. However, IT understands that there are exceptions and will adjust its procedures/schedule accordingly. IT hopes to have your continued support, while continuing to provide support and assistance to the FPA team.

Parking Lot Safety

Drive Carefully in FPA Parking Lots - Parking Lot Etiquette is Expected

FPA employees and visitors alike are expected to respect safety rules and regulations on all Flood Protection Authority property including parking lots.

Parking lot safety is probably not what you are thinking upon entering a Flood Protection Authority Facility. Slower speeds may give you a false sense of security when in fact parking lots can be more dangerous than driving on a roadway. Both the driver and the pedestrian should remain vigilant to their surroundings. The driver should remember that restricted lanes and spaces in FPA parking lots leave little room for evasive actions to avoid an impact. A driver should constantly be looking from left to right and the pedestrian should always look to left and right before entering into a traffic lane. A thing to remember is that the driver will become a pedestrian and the pedestrian may become the driver.

Put down your cell phone, remain buckled-up, pay attention to your surroundings, drive at a slow rate of speed, follow the direction of the parking lot arrows and do not leave the traffic lane to avoid the speed bumps.
