Police Co-Employees of the Month Recognized by Board



The Board recognized Sergeant Noel Sanders and Officer Tammy Canfield as Police Co-Employees of the Month at the October 17th Board meeting.

Noel Sanders is a Police Sergeant-A and Tammy Canfield is a Police Officer 2-A with the Orleans Levee District Police Department.

On September 2, 2019, while on patrol, Sgt. Sanders observed a vehicle driving erratically on Lakeshore Drive. After alerting the vehicle to stop, it was discovered that the driver exhibited signs of severe medical distress.

Sergeant Sanders immediately determined that the elderly woman was suffering from Hypoglycemia (Diabetic Shock). Officer Canfield arrived on the scene and was able to assist by keeping the woman stable and conscious until Emergency Medical Services arrived to perform advanced medical care.

The actions of these officers enabled the victim to receive immediate and potentially lifesaving medical care, preventing serious bodily injury and loss of life.

Officer Canfield is certified through the American Heart Association and holds the certification of a Basic Life Support Instructor. Her certification covers basic life support and first aid. In 2018, Officer Canfield conducted a number of First Aid classes for FPA employees.

Sgt. Sanders and Officer Canfield were commended by the Orleans Levee District Police Leadership for their exemplary performance and dedication to duty in this life saving event.

Sgt. Sanders and Officer Canfield epitomize the core values of the FPA and are a tremendous asset to the FPA, the law enforcement community and the public.

Operations Employee of the Month



Russell Gelvin is currently a Levee Maintenance Foreman B working out of the Lake Borgne Basin Levee District of the region. He is approaching his second anniversary as a Foreman B. Like the other supervisors throughout the region, Russell on any given day has to "wear many different hats". On any given day, he coordinates the activities of the Levee Maintenance crews, deals with equipment issues and works to repair items or equipment that needs to be repaired in order to keep the equipment in the field.

Where Russell goes above and beyond is two-fold. First, Russell is licensed to apply herbicide and runs the herbicide application process for the Authority in St. Bernard

Parish. On any given day, Russell works side by side with crew members to apply the herbicide in the field. Second, Russell has in the past, and even more recently, been called upon to provide historical knowledge of the various aspects and components of the whole flood protection system in this area of the region. This institutional knowledge that he possesses and provides when called upon has and is very valuable when planning activities or working through issues that arise. His contributions to the overall success in this area of the Region is greatly appreciated by his colleagues.

A colleague of Russell's states, "Russell has the knowledge, wisdom and impeccable memory needed for operating the LBBLD. He knows the system better than anyone, and knows what needs to be done and how to get the job done. His team respects him as a hard working Foreman that will grab a weed eater and pitch in when manpower is short. His herbicide certification and spraying is vital to the maintenance of overgrowth of canal banks in St. Bernard Parish."

EJLD Police Officers Commended for Life Saving Effort




Officers Scott Meunier and Myles Ledet were commended by EJLD Police Leadership for their life saving efforts taken on a call for service. The officers responded to a dispatched call of an unresponsive male in his late 60's. Upon arrival, one minute later, the Officers found the victim lying in a supine position and unconscious on an upstairs bedroom floor and began CPR in an effort to revive him. EMS arrived on the scene and took over life saving efforts about ten minutes later. The patient's pulse returned and he was transported to East Jefferson General Hospital for further treatment.

Officers Meunier's and Ledet's quick response and dedication to duty is a credit to the EJLD Police Department, the FPA, and the community we serve.

FPA's K-12 School Program



The Flood Protection Authority's K-12 School Program was developed by Anne Rheams, the FPA'S Education Consultant, and is supported by Antwan Harris, FPA Public Information Director. The major feature of the School Program is the curriculum guide entitled, "Keepin' Your Head Above Water: Know Your Flood Protection System." Anne co-wrote the 1st Edition with Gena Asevado, St. Bernard Parish Public Schools Science Curriculum Director. Anne is currently revising and adding new lessons and activities for the 2nd Edition of the curriculum with Dinah Maygarden, Director of the University of New Orleans' Coastal Education Program.

The curriculum meets the National and State Science Standards and is based on contemporary educational models. Major topics covered in the curriculum include: Geography of Water (where do students live in relation to the surrounding waterbodies); Storm Surge (what is it and what protects them - HSDRRS), Risk associated with tropical cyclone systems (what they can do to protect themselves and their families). The activities of each of these lessons are hands-on and interactive, and fit into the framework of STEM Programs (Science, Technology, Engineering and Math).

The K-12 School Program is part of the Flood Protection Authority's public outreach to enhance understanding of the its mission. The program not only ensures that future generations understand the risks and challenges associated with living with water, but that students will share the information and their learning experiences with families and friends.

Student and Teacher Programs in October 2019

8th Grade Science Classes All-day Workshops

Students learned about the following topics included in the curriculum guide:

- Viewing Flood Protection Authority videos of the Lake Borgne Storm Surge Barrier and the Permanent Canal Closures and Pumps;
- Using interactive mapping activities that orient students with the waterbodies that surround their homes and schools:
- Using a group discussion format about storm surge associated with tropical cyclone systems;
- Using the Flood Authority's website to identify types of flood protection structures that are operated and maintained by the Flood Authority;
- Brainstorming about how students will convey information that they've learned related to hurricane risk and preparedness to their families, friends and neighbors;








EJLD Night Out Against Crime/Open House
