2019 Wrap-Up / 2020 Look-Ahead

As we close out 2019, I wanted to take this opportunity to highlight the outstanding accomplishments the FPA has achieved this year and what we will focus on in 2020.

Over the last 12 months, the FPA has continued to become a more regionally-focused organization, highlighted by the challenging task of merging all three areas of the Maintenance Department in October. We dealt with the record-breaking high river event on the Mississippi River and daily inspections for months on end. Our police operations continue to become more and more well-integrated with our local, state and Federal partners. And we successfully completed and moved into new facilities at Franklin and Kenner.

The highlight of 2019 was our performance during Hurricane Barry. For the first time, we successfully closed every single gate and complex structure in our system and did it within a 48 hour period under stressful conditions. This is something that every employee should take great pride in - and we did it without a single safety incident.

Each year, I set some overarching themes for the organization to focus on. In 2019, those included full regionalization of the Authority, better project cost and schedule management, and documenting our operational procedures. I am happy to report that we made great progress in all those areas.

On December 19th at our Annual All-Hands Safety Meeting, you will hear me focus on one of the major themes for 2020 – Improving our Safety Performance. While in 2019 our numbers improved, we can still do better. Our goal is zero incidents – which means every day every employee goes home to their loved ones with no injuries. It takes focus and thought from every single employee, regardless of the task they are working on or whether they are a supervisor or not, to achieve that. You will hear more about this on the 19th and throughout 2020. I challenge each of you to not only be safe, but look out for each other. If we can accomplish everything we did during Hurricane Barry without any safety incidents, we can do it throughout 2020 as well.

As always, I remain grateful for the work that each of you do to help keep the people and property of greater New Orleans safe.

Three Stages of Disaster Response

- Denial
- Deliberation
- Decisive Moment

AVOID / RUN

- Know your exits
- Leave ASAP
- Call 911

DENY / HIDE

- Lock the door
- Lights out
- Keep out of sight

DEFEND / FIGHT

• As an absolute last resort

WHEN THE POLICE ARRIVE

- Hands up & palms out
- Follow commands
- Do not move unless told to do so

Employee of the Month Recognized by FPA Board



Roger Colwell was recognized by the Board at its meeting on November 21st as the FPA's Employee of the Month.

Roger is a GIS Analyst Supervisor in the Engineering Department. Roger is always professional and personally accountable and he holds his staff to similar high standards, but always recognizes them for their individual and team contributions.

Roger understands all aspects of the FPA Mission and works well independently or as part of a team.

Roger contributes to the Engineering Department on Permitting, Levee Inspection, Mapping, Document Control, ICC and EOC. He also contributes to the IT, Operations and Maintenance Departments in similar ways. Roger's title is GIS Analyst Supervisor, but his service to the FPA and the public goes way beyond GIS Management of geographical and spatial data, mapping and graphic display. He knows our entire system as well as anyone in the department and the FPA's Emergency Operations Procedures. He has provided valuable input on the design and set up of our Emergency Operations Center.

Roger wears an IT hat as well and recently led the efforts for the FPA to completely automate our Levee Safety Permit Process making it the only completely on-line system in the entire State of Louisiana. To date this new process has recovered approximately \$58,000 on a total investment of \$119,000 in less than one year of implementation. In addition, the new automated on line system has reduced the number of permit reviewers and process personnel by two.

On top of all his other contributions Roger has championed our new Drone Program, was our first of now five licensed Drone Pilots and has co-authored our Unmanned Aerial System (UAS) Policies and Procedures Manual. He is currently developing our procedures for performing periodic levee Inspections with Drones with the first assignment to be the 22 miles of the 40 Arpent Levee in the LBBLD. Not only will this save on outside consultant costs, but it also provides a significant improvement on baseline condition mapping that can be measured against future aerial surveys with much more detail and accuracy.

Roger is truly the "Swiss army knife" of the Engineering / GIS department. When tasks arise that do not necessarily fall within an individual department or employee's jurisdiction or responsibility, Roger has continually been the go to person to manage or complete these tasks.

Roger's contribution is essential to the FPA's successful accomplishment of its mission and he is a tremendous asset to the organization.

Operations Employee of the Month

Mike LeBlanc was nominated by his colleagues and selected as the Operations Employee of the Month. Mike is a Maintenance Foreman in Group 311 - Operations and Maintenance / Floodgates.

Mike handles the scheduling of employees from all groups to work high tide events for Bayou Bienvenue. He does an excellent job coordinating the schedules for both the manning of the structure itself and the ICC/EOC. Even with the recently experienced extended high tide event that ran for 35 days (9-29-19 thru 11-2-19), Mike was able to keep the personnel scheduled to cover both the structure and the ICC/EOC and at the same time successfully handled his daily job duties.



Mike is a key asset to the FPA and his contribution is crucial to the success of the FPA's mission to protect the citizens of the region from flooding.

Police Employee of the Month

The Board recognized Sgt. Lacy Gerhold as the Police Employee of the Month at its November 21st meeting. Sgt. Gerhold is an O.L.D. Police Reserve Officer.

On October 9th Sgt. Gerhold was summoned by a victim, who informed the sergeant that her vehicle was stolen and located on the 100 block of Royal Street. Sgt. Gerhold approached the vehicle ordering the driver to exit the vehicle. Moments after exiting the vehicle, the driver fled running on foot in an attempt to elude the sergeant.



Sgt. Gerhold pursued the suspect on foot for numerous blocks, giving a description and locations via radio to responding police units. This enabled Louisiana State Police and New Orleans Police Officers to apprehend the suspect. The investigation revealed the vehicle was stolen from Mississippi, and contained two firearms, 11.5 grams of crack cocaine, .8 grams of heroin and .1 gram of crystal methamphetamine. The suspect was charged with a felon in possession of a firearm.



Sgt. Gerhold was also commended for demonstrating courage and great attention to detail for her response in an incident that occurred on November 22nd while working a paid detail in the 2400 block of Martin Luther King Boulevard. While sitting in her marked police unit, Sgt. Gerhold witnessed an attempted armed robbery in progress by a knife wielding suspect. She observed the suspect approach the victim at a close distance, pull a knife from his pants pocket, and point it at the victim's chest. She activated her siren in an attempt to distract the suspect while she called for assistance from backup units. Sgt. Gerhold was able to apprehend the suspect and handcuff him without incident.

Sgt. Gerhold received Letters of Commendation from Capt. Michael Brenckle for her exemplary performance and dedication to duty in both of these incidents (pictured left).

Sgt. Gerhold is a great asset to the O.L.D. Police Department, the FPA and the citizens we protect.

The subject aggressively attacked the officer and successfully disarmed the officer's Taser. Ms. Hayes acted heroically by warding off the counterparts and staying with the officer to ensure his safety.

Ms. Hayes was commended for her courage, exemplary performance and dedication as a citizen in rendering aid to a Law Enforcement Officer in distress.

Police Officer Arthur Agee Responds to Life Saving Service Call

On November 19th, a call came out as a male who fell on the floor not breathing and turning blue. Officer Agee was the first unit on scene. The subject, who was located in the bathroom of the residence, appeared pale and blue and had no pulse. Officer Agee began CPR until the subject began to show signs of life and a faint pulse. The subject was monitored until the arrival of EMS. While waiting on EMS, it was assumed that the subject had overdosed on an unknown narcotic. EMS arrived on the scene and administered Narcan through an IV. The subject came to and was transported to East Jefferson Hospital. The Jefferson Parish Sheriff's Office conducted a MIC on the incident.
