## NOMINATING COMMITTEE FOR THE BOARD OF COMMISSIONERS OF THE SOUTHEAST FLOOD PROTECTION AUTHORITY – EAST BANK (SLFPA-E) AND SOUTHEAST FLOOD PROTECTION AUTHORITY – WEST BANK (SLFPA-W)

Minutes of the Combined (SLFPA-E and SLFPA-W) Nominating Committee Meeting Friday, September 19, 2025

The nominating committee met at approximately 10:00 A.M., on Friday, September 19, 2025 at the SLFPA-W office located at 7001 River Road, Marrero, LA 70072.

Mr. Curole called the public meeting to order and directed Mr. Barth to call the roll.

It was moved by Mr. Thompson, seconded by Ms. Mattei, and approved unanimously by the members in attendance to close nominations and to send the names of Mr. Mitchell and Mr. Costigan as candidates for the Governor's appointment to the SLFPA-W Board.

The committee discussed how to select two candidates from a larger pool of applicants. It was moved by Gary Huntley, seconded by Norma Jean Mattel, and approved unanimously by the members in attendance to adopt the following procedure for the September 19, 2025 SLFPA-East candidates' selection:

- 1. The committee will open the floor for public comments regarding the candidates.
- 2. The name of each applicant will be read aloud. A nomination must be made and seconded to add an applicant's name to the voting ballot.
- 3. Once a voting ballot is created, a motion will be made to approve the ballot. If the motion is seconded, committee members will vote to accept or reject the ballot.
- 4. After the ballot is approved, each committee member will cast two votes for two different applicants.
- 5. The two candidates with the highest number of votes would be voted for approval.
- 6. In the case of a tie, a revote will be conducted among the tied individuals.
- 7. A total quorum vote for the top two candidates would confirm the recommended nominees.

The committee reviewed the SLFPA-E applicants/applications.

Windell Curole opened the floor for public comments. Pete Vicari, President of SLFPA-East, spoke in favor of Kerwyn King and addressed the need of business owners on the SLFPA-East board.
