The regular monthly Board Meeting of the Southeast Louisiana Flood Protection Authority-East (Authority or SLFPA-E) was held on Thursday, June 16, 2016, in the St. Bernard Parish Council Chambers, St. Bernard Parish Government Complex, 8201 West Judge Perez Drive, Chalmette, Louisiana, after due legal notice of the meeting was sent to each Board member and the news media and posted.

PRESENTATIONS:

Mr. Hassinger advised that the Board takes the opportunity each month to recognize an employee of the Authority whose work excels. He stressed the importance of the Authority's mission and noted that it can only be successful if its employees are motivated, interested and take ownership in their work and do a good job. The Board recognized Roch Canzoneri, a Mobile Equipment Operator 2 who has been employed by the Lake Borgne Basin Levee District (LBBLD) since November of 2014. Mr. Canzoneri is the newest employee on the Levee Crew and is currently the only LBBLD employee with a Class A CDL. Nick Cali, LBBLD Executive Director, had informed the Authority that he was impressed with Mr. Canzoneri's attitude and ability to quickly learn all of the equipment and operations. Mr. Cali had stated that he could give Mr. Canzoneri virtually any task and count on him to get it done right, and that if he sees something that needs to be done, he takes the initiative and does it. In the months since the LBBLD was forced to implement a Layoff Avoidance Plan and began transitioning personnel from Pump Station Operators to Equipment Operators on the Levee Crew, Mr. Canzoneri did a great job of helping to train the new employees on the operations and maintenance of the various pieces of equipment and getting them acquainted with their new roles. Based on his good work to this point and his potential, Mr. Cali and Mr. Canzoneri's supervisor have decided to move him up to a Mobile Equipment Operator 1/Heavy and give him more responsibility. Mr. Hassinger congratulated Mr. Canzoneri on his promotion and expressed appreciation for the work that he and his colleagues at the LBBLD perform.

Mr. Hassinger presented a plaque to Tyrone Ben with the resolution adopted by the Board recognizing and expressing appreciation for Mr. Ben's service on the Board and his commitment and contributions to the SLFPA-E and to the citizens St. Bernard Parish and Southeast Louisiana.

Mr. Hassinger presented a plaque to Stephen V. Estopinal with the SLFPA-E Certificate of Congratulations saluting and commending Mr. Estopinal for receiving the Louisiana Engineering Society Leo M. Odom Service to the Profession Award.

Mr. Hassinger introduced Lenore Duplessis and Michelle Walsh, Executive Assistants to St. Bernard Parish President Guy McInnis. Ms. Duplessis advised that President McInnis was unable to attend today's meeting due to a conflicting coastal meeting in Baton Rouge. Ms. Duplessis stated that President McInnis asked that she express his appreciation to Mr. Estopinal for his service to St. Bernard Parish. Ms. Duplessis, who serves as Deputy Council Clerk, expressed her personal thanks to Mr. Estopinal for his help over the years to the Parish. She presented a Presidential Commendation to Mr. Estopinal commending him for his years of dedicated service to the residents of St. Bernard Parish as a member of the SLFPA-E.

1. Bayou Backer Erosion Control – Joseph Lazaro

Mr. Kemp introduced Joseph Lazaro, the inventor of Bayou Backer Erosion Control, and requested that Mr. Lazaro provide a presentation on the product.

Mr. Lazaro advised that in 2008 a model of the Bayou Backer Erosion Control was brought to the LSU wave tank. The product was left in the wave tank for four days under the direction of Dr. Gregory Stone. Dr. Stone wrote a very favorable report in April of 2008 indicating that Bayou Backer reduces wave energy in a simple, effective and inexpensive way. He explained that a roll of plastic dispenses strips six to eight feet in length. The strips are folded in half and are pushed into the mud to a depth of two to three feet. The plugs are spaced two feet apart in swaths sixteen to twenty-four feet wide. The wave tank study established that the product effectively dispenses and dissipates incident waves up to 64 percent. The tests were run to hurricane strength and the tested plugs reduced wave energy. Mr. Lazaro reviewed the results of tests in Week's Bay in 2008 where 400 plugs were hand planted and where wave energy was reduced sufficiently to allow natural grasses to grow behind the plugs. Proposals were developed by Wildlife and Fisheries for a project in Marsh Island in 2008 and NRCS for projects at Bayou Perot and Shark Island. A permit was received in 2014 to install 800 plugs in Schooner Bayou. In 2015 there was significant aquatic growth in the formerly open area and in and around the plugs. The product establishes a surface on which floating aquatics and sediments can be stopped and given a place to anchor resulting in accretion. A second permit request is being developed for 12,000 plugs to be installed in Little Vermillion Bay to prevent the erosion of two terraces.

Mr. Luettich inquired about concerns relative to the use of plastics in the environment. Mr. Lazaro responded that the plastic in Bayou Backer is a non-biodegradable product, which means that it does not feed the food chain. He pointed out that plastic lasts for hundreds of years and that over time accretion will eventually cause the material to sink.

Mr. Kemp commented that the SLFPA-E is interested in any methodology that can be used to address wave action against the levees. He asked that Mr. Lazaro return when more data has been collected on the product.

Mr. Lazaro introduced his partner Jeffery Peterman, General Counsel for Grastic Erosion Control. He commented on the cost effectiveness, successful utilization and significant potential of the Bayou Backer Erosion Control.

Mr. Luettich commented that the Bayou Backer Erosion Control seems to be compatible with what the State is trying to accomplish in the Master Plan. Mr. Lazaro responded that he spoke with representatives of the Coastal Protection and Restoration Authority (CPRA) and other entities. He added that he has worked on Bayou Backer for 14 years and that it had taken six years to obtain a utility patent.

PUBLIC COMMENTS:

Beverly Crais commented that a representative of the U.S. Army Corps of Engineers (USACE) provided a presentation at the Board's September, 2015, meeting relative to

the steps that would be taken by the USACE to stop the flooding along the West Return Floodwall. A statement was made that the work would be completed by the rainy season. She commented on the damage from the flooding to her trees, fence and her driveway. She stated that to-date the USACE has not done anything to the area behind her property. She advised that on June 4th the swale filled up and water flowed onto her property for the thirteenth time. She stated that she and her husband have filed three claims in the past 26 months with the USACE. All of the claims have been denied. The USACE stands behind a veil of immunity and points to the contractor, CPRA and the design company. She commented on the impact of the mistakes made by the USACE.

Craig Berthold introduced Sandra Prince Madison. He advised that Ms. Madison lives along the London Avenue Canal and received one of the anonymous letters relative to the 17th Street Canal litigation settlement. Ms. Madison explained that the majority of people who live along the London Avenue Canal received the letter in the mail on or around May 3rd and wondered if there is any avenue of pursuit. The residents also asked the reason for the suit not being a class action in regards to the property taken after Hurricane Katrina. Nyka Scott, SLFPA-E Executive Counsel, advised that she would speak with Ms. Madison after the Board meeting.

John Kofert, President of Citizens Against Widening the Industrial Canal, commented that the USACE advised by letter that the scoping report for the project was completed and that it would be provided as an appendix to the Supplemental Environmental Impact Statement that the USACE tentatively plans to issue in November or December, 2016. He expressed concern that the project was conceived for navigational interests and that there is very little concern or provision for levees. He asked that the SLFPA-E follow the project and share what it can with his organization so that it can provide assistance.

COMMITTEE REPORTS:

Finance Committee: The Finance Committee did not meet during the month of June, 2016. Mr. Luettich advised that he met earlier today with the SLFPA-E's Information Technology (IT) Consultant to discuss the implementation of the recommendations contained in the Waypoint Report. He advised that he would be happy to take the project under the purview of the Finance Committee.

Operations Committee: The Operations Committee did not meet during the month of June, 2016.

Legal Committee: The Legal Committee did not meet during the month of June, 2016.

Coastal Advisory Committee: The Coastal Advisory Committee did not meet during the month of June, 2016.

REGIONAL DIRECTOR'S REPORT: Robert Turner, SLFPA-E Regional Director, reviewed the highlights of the Regional Director's Report (copy appended to minutes). He provided the following additional comments:

- State of the Coast Conference – Mr. Turner reported that he attended the State of the Coast Conference. He advised that he was impressed with the work being done by The Water Institute of the Gulf (TWIG) in regards to the State Master Plan and that the group possessed a significant amount of information and data that could be used by the SLFPA-E relative to future benefit-cost analyses (BCA) for levee lifts. The SLFPA-E and TWIG will be considering the issues relative to the future BCA over the next several months to determine the possibilities.
- IHNC Surge Barrier Tours – SLFPA-E staff conducted a record number of tours of the IHNC Surge Barrier over the past month. Two groups from the Netherlands visited New Orleans and toured the Surge Barrier: 1) the Director General of Rijkswaterstaat accompanied by a Dutch contingency; and 2) a group of individuals from the Netherlands belonging to the I-Storm Network. The Director General's visit to New Orleans was relative to crisis management and flood emergencies, particularly in regards to evacuation and response during and after an event. Two days of meetings were held with the I-Storm group for an exchange of information. The exchange of information was particularly helpful since the SLFPA-E is currently performing a risk assessment for the barrier gates. The SLFPA-E is also developing an asset management program in order to collect data relative to the Surge Barrier's maintenance activities. The SLFPA-E is able to draw upon the expertise offered by the I-Storm Network for these types of activities. Mr. Hassinger commented that he met some of the representatives of the I-Storm Network. The representatives who visited New Orleans on a previous occasion stated that they saw a very apparent marked increase in the degree of ownership, enthusiasm and eagerness to learn in the staff manning the operations and maintenance positions. The representatives were extremely complimentary and very positive about what they thought the future held for the Authority.
- Table Top Exercise – Mr. Turner reported that he attended the Table Top Exercise held at the USACE Vicksburg District. The Table Top Exercise was hosted by the Mississippi Valley Division and lasted approximately eight to nine hours.
- 2016 Hurricane Season – Mr. Turner advised that the levee districts are prepared for the upcoming hurricane season. The Emergency Operations Procedures (EOP) Manuals have been transmitted to the appropriate individuals. The Seabrook Complex Structure is fully operational.
- IHNC Surge Barrier – The SLFPA-E submitted the information it possessed on the scour hole that is developing near the Surge Barrier to the USACE. SLFPA-E and USACE representatives met several times relative to this issue. An analysis confirms that the scour hole is not a stability issue for the wall at this time. The USACE's Hydraulics staff is investigating the situation to determine whether the scour hole has reached equilibrium and, if not, the potential depth that the hole may reach, along with possible solutions for the velocities at this location.
- Armoring – The armoring projects are proceeding. Several issues have developed relative to the project in New Orleans East and the USACE has been requested to make modifications regarding the application of materials and to revise the side slopes in a number of areas.

- Mississippi River – The river level dropped below elevation +11-ft. and the Flood Fight has been discontinued. The river is forecasted to drop to elevation +7-ft. by mid-July. The river will probably reach elevation +6-ft. at the Carrollton Gage prior to August 1st. Should this occur, the USACE plans to close the IHNC locks for approximately six months for major repairs. The closure of the locks will impact marine traffic through the IHNC Surge Barrier Sector Gate. Maritime traffic through the GIWW would lessen; however, the closure will impact the evacuation of vessels in advance of a major storm event. The U.S. Coast Guard (USCG) conducted its first inventory of vessels in the IHNC corridor on June 15th. The inventory will continue on a monthly basis and will be used to estimate the amount of time that will be needed for the evacuation of vessels. The USCG is also attempting to devise a method to control traffic between Mobile and New Orleans in advance of a storm due to the evacuation path while the locks are closed. The maritime industry has been made aware of the lock closure and potential impacts.
- IHNC Surge Barrier Barge Gate – The Barge Gate is anticipated to be closed prior to June 30th for at least several months due to potential reliability issues. The USACE will replace the hydraulic oil tank reservoirs for the two windlasses. There is concern that the type of tank originally installed may have caused contamination of the oil over the past several years. The use of the Seabrook Complex to control current velocities through the Surge Barrier Sector Gate while the Barge Gate is closed is being investigated. The U.S. Geological Survey (USGS) has agreed to reprogram the current velocity meter at the Sector Gate and do whatever is needed to provide usable data to the SLFPA-E and maritime industry. The SLFPA-E is continuing to monitor the current velocities at the Seabrook Complex for planning purposes.
- Indefinite Delivery-Indefinite Quantity (ID-IQ) Contracts – The SLFPA-E received a total of 111 submittals to the Requests for Qualifications to provide various engineering, surveying and inspection services on an ID-IQ basis.

Mr. Estopinal inquired about the initiation of work relative to the elevations along Paris Road and their comparison to historical data. Mr. Turner responded that Linfield, Hunter and Junius has been contacted and will submit a proposed scope of work within the next two weeks.

Robert Garner, SLFPA-E Police Superintendent, reported the following statistics for the levee district Police Departments for month of May: Officers worked approximately 8,000 hours, the Reserve Division contributed over 520 additional hours, 365 citations were issued, and 320 vehicle checks and 250 pedestrian checks were completed. Interviews were conducted and several individuals were hired at the Orleans Levee District (O.L.D.). Several applications were received for the East Jefferson Levee District (EJLD). Officers have completed active shooter courses and are participating in additional courses. Protection was provided for several candidates arriving at the New Orleans Lakefront Airport and Louis Armstrong International Airport to facilitate the needs of the Secret Service. U.S. Customs and Border Protection was welcomed back to the New Orleans Lakefront Airport.

REPORT BY SLFPA-E EXECUTIVE COUNSEL: Nyka Scott, SLFPA-E Executive Counsel, provided the following report:

- Nine Cooperative Endeavor Agreements are being negotiated, drafted or finalized.
- Two new law suits were filed during the past month. One of the suits involved a parking lot owned by the O.L.D.; however, Ms. Scott advised that she was able to have the suit quickly dismissed. The second suit is in the beginning stages and involves the EJLD and SLFPA-E. The Authority's insurer has been contacted regarding the suit.
- Several contracts are under negotiation or have been completed. One issue remains in the negotiation of the architect's contract for the EJLD consolidated facilities and safehouse. The contract with Weatherflow for weather monitoring equipment has been completed. The Legal Department is awaiting the return from Tremaine and Associates of the proposed contract amendment.
- The Regional Finance Director position will be posted on Friday. The position will remain posted for two weeks. The applications will be provided by Louisiana Department of Civil Service and interviews will be scheduled. An offer has been made to an individual to fill the position of Human Resources (HR) Director. Six interviews were conducted by Mr. Turner, Ms. Scott and Dee Everett, the SLFPA-E's HR Consultant. Approximately 40 applications were received. The three interviewers unanimously agreed on the candidate that was selected. The selected individual has a significant background in HR issues and will begin work in the second week in August.
- The buildout of the conference center in the New Orleans Lakefront Airport Terminal will be completed by the end of July.
- The SLFPA-E recently approved a servitude over a piece of O.L.D. property at Lake Marina Drive. The new owner of the property adjacent to the O.L.D. property expressed an interest in purchasing the property. Steps are being taken relative to the purchase request.
- The 2016 Regular Legislative Session ended on June 6th. House Bill (HB) 629 concerning a proposed SLFPA-E millage died in committee. HB 1149 concerning the nominating committee and seating of SLFPA-E Commissioners passed and is expected to be signed by the Governor and become effective on July 1st. Funding for the O.L.D. Police Station initially placed in the Capital Outlay Budget was struck. The SLFPA-E was able to have the funding reinstated; however, HB 2 died before the end of the Regular Legislative Session. The bill is being taken back up in the current Special Legislative Session.
- The SLFPA-E currently has two Community Development Block Grants (CDBG). The SLFPA-E Grants Administrator will meet with the Regional Director regarding the use of the approximately \$230,000 remaining in one of the CDBGs. The SLFPA-E has a \$500,000 CDBG to fund risk assessment for the Hurricane and Storm Damage Risk Reduction System (HSDRRS). Phase II of the risk assessment is underway. The Grants Administrator submitted nine different grant applications during the past several months. Two of the applications were to Homeland Security for grants for security cameras/infrastructure support and portable radios. A grant

was awarded by the Louisiana Highway Safety Commission for a “Click It or Ticket” campaign and for the EJLD to participate in a “Drive Sober or get Pulled Over” campaign. The funding will be used for overtime payment for officers working the campaigns. The Grants Administrator also has several grant applications in process. One of the applications is for a North American Wetlands Conservation Grant for funding for conservation and recreation of the Central Wetlands. Several grant opportunities are being researched, such as a Wildlife and Fisheries grant for assistance with aquatic weed infestation management. Four EJLD Police Officers and four O.L.D. Police Officers will attend the VALOR Initiative Training being offered in Belle Chasse, LA, in July.

WHEREAS, the nature and complexity of these structures will require the District to incur periodic maintenance costs that, together with other project costs and operation and maintenance (O&M) expenditures, will exceed any one-year revenue stream of the Special Levee Improvement Fund; and

WHEREAS, management believes that it is prudent to set aside funds annually in the Special Levee Improvement Fund, in amounts that can be funded by current revenue, and will accumulate to the amounts needed for the periodic maintenance noted above.

BE IT HEREBY RESOLVED, that the Southeast Louisiana Flood Protection Authority-East approves the escrow of funds necessary for significant, periodic maintenance to complex structures in the amount of \$2 million for fiscal year 2016.

BE IT FURTHER RESOLVED, that the SLFPA-E approves the identification of such funds as committed to maintenance of complex structures.

RESOLUTION NO. 06-16-16-18 - AUTHORIZATION TO ESCROW FUNDS AND PURSUE ARRANGEMENT OF A BENEFIT TRUST FUND RELATED TO POST EMPLOYMENT HEALTH AND LIFE BENEFITS FOR O.L.D. RETIREES

Ms. Scott noted that amount to be escrowed is \$1.315 million to partially fund the past liability plus \$1 million to fund the current year liability.

On the motion of Mr. Luetlich,
Seconded by Mr. Estopinal, the following resolution was offered:

WHEREAS, the Orleans Levee District ("the District") and the Southeast Louisiana Flood Protection Authority East (SLFPA-E) have committed to employees of the District that it will fund part of the health and life insurance costs for those employees after their retirement; and

WHEREAS, authoritative accounting principles require the current recognition of the cost and the estimated prior and current actuarially determined liability for those future benefits, in the annual financial reports of the Authority in order to provide reasonable assurance that the District will have the financial resources to fulfil those commitments; and

WHEREAS, funding of such liabilities can be minimized when money is set aside annually, and invested, allowing the returns on the investment to offset the total amount due for funding the liabilities; and

WHEREAS, at fiscal year end June 30, 2015, the accumulated recorded liability of \$7,757,564 less the \$2,500,000 previously set aside in the OPEB escrow account totaled \$5,258,000; and

WHEREAS, the estimated annual cost, in excess of current payments for the retirement plan, is approximately \$1,000,000; and

WHEREAS, the District's management recommends that funding of the June 30, 2015 \$5,258,000 liability over a 4-year period be authorized; and

WHEREAS, the costs for funding the June 30, 2015 liability less the amount in escrow over a 4-year period, will be approximately \$1,315,600; and

WHEREAS, the total annual costs for funding the current annual required contribution, and the June 30, 2015 liability is approximately \$2,315,000.

BE IT HEREBY RESOLVED, that the Southeast Louisiana Flood Protection Authority-East approves the deposit of 1/4th of \$5,258,000, or \$1.315 million, for the 2016 fiscal year, plus the annual required \$1 million contribution of post-employment health and life insurance benefits into an escrow account.

BE IT FURTHER RESOLVED, that the SLFPA-E approves the identification of such funds as committed to "Other Post-Employment Benefits".

BE IT FURTHER RESOLVED, that the SLFPA-E authorizes legal counsel to proceed with the creation of a Trust suitable as a repository and investment management of the funds dedicated to the funding of such benefits and the transfer of any funds escrowed for that purpose when appropriate.

BE IT FURTHER RESOLVED, that authorization for each year's contribution must be re-authorized by the SLFPA-E, to assure that the funds are available to meet the overall intent to fund the liability annually.

RESOLUTION NO. 06-16-16-19 - GIWW SOUTH SIDE DRAINAGE IMPROVEMENTS

Mr. Gillen advised that bids were received to add clay fill to the levee toe to improve the drainage along the GIWW South Side. The contractor was initially authorized to provide 1,000 cubic yards (CY) of fill. As the work progressed, it was determined that an additional 1,200 CY of fill would be required. A change order in the amount of \$46,800 is required to the contract.

On the motion of Mr. Luettich,

Seconded by Mr. Estopinal, the following resolution was offered:

WHEREAS, erosion from the Gentilly landfill has moved drainage to the protected side toe of the GIWW South Levee for which the Orleans Levee District (O.L.D.) received a comment on the U.S. Army Corps of Engineers Annual Inspection Report; and

WHEREAS, the O.L.D. received bids and executed a contract in the amount of \$49,900 with Cycle Construction, LLC to perform the required drainage improvements; and

WHEREAS, the work site was overrun with vegetation making it difficult to properly estimate the amount of clay fill, initially estimated at 1,000 cubic yards (CY), required to move drainage away from the protected side levee toe; and

WHEREAS, after the vegetation was cleared and the soft soil settled, the O.L.D. determined that total amount of clay fill required to complete the project was 2,200 CY (1,200 additional CY at \$39 per CY); and

WHEREAS, an adjustment is needed to the contract to revise the total contract amount to \$96,700; and

WHEREAS, additional funds for this project are available in the approved FY 2016 Special Levee Improvement Fund Budget.

BE IT HEREBY RESOLVED, that the Southeast Louisiana Flood Protection Authority – East authorizes the O.L.D. Executive Director to execute a change order in the amount of \$46,800 to the contract with Cycle Construction, LLC to provide for

a total contract amount of \$96,700 to complete the drainage rerouting and repairs at the GIWW South side levee toe, and authorizes the corresponding adjustment to the project budget.

REGIONAL DIRECTOR'S REPORT

June 16, 2016

HSDRRS Project Status Update

IHNC-01 – Seabrook Complex The steel Vertical Lift Gates (VLGs) were blasted and repainted off-site by the Corps' contractor. They were put back in place before June 1, 2016. The Corps' contractor damaged three of four PLC's. Orleans Levee District has completed repairs on all three PLC's.

Orleans Levee District contracted with Hydradyne, LLC to fully inspect the lift gate hydraulic cylinders prior to reinstallation by the Corps. The inspection led to repairs of the cylinders for scratching and packing replacement and removal of metal shavings.

IHNC-02 – Lake Borgne Surge Barrier We continue working with USGS and the Corps to rectify the problem with the Corps' current velocity meters at the GIWW Sector Gate. USGS and the Corps have not yet made the necessary changes to obtain accurate real-time velocity readings.

We received a written proposal from Arcadis to conduct a literature review and model inventory on the GIWW-IHNC corridor, and a contract has been executed to complete this work.

The Corps is preparing to refurbish the two windlasses on the Bypass Barge Gate and replace the rusted hydraulic oil tanks. We are awaiting the Corps' work schedule. To avoid closure problems and any further damage to the windlasses the barge will be closed before June 30, 2016 and remain closed until all repairs are completed by the Corps.

Multi-beam hydrographic surveys were taken along the surge barrier on April 28, 2016. The surveys show a scour hole is developing along the flood side of the barrier about 1,000' south of the Sector Gate in an area where a sheet pile wall was terminated about 3' shy of the barrier. The hole is 12'-14' deeper than the surrounding channel bottom and extends 6'-12' out from the flood side face of the barrier. A distress report was submitted to CPRA and the Corps on May 10, 2016. The report requests technical assistance from the Corps to investigate impacts to wall stability and provide a remediation plan if necessary prior to the start of the 2016 hurricane season. The Corps has conducted a stability analysis of the barrier wall and has told us that there is no immediate threat of instability. We are awaiting additional information from the Corps regarding a permanent fix.

LPV-03.2B – West Return Wall North of I-10 The March 16, 2016 response from the Corps on the distress report we filed regarding the seepage that occurs during high lake levels at the Grand Lake Drainage Pump Station says the seepage is an O&M issue and will not affect the stability of the wall. In response, East Jefferson Levee District & CPRA questioned the previous grouting effort at that location and requested a reassessment of the Corps' most recent response. There is no indication of floodwall distress at this time, and we continue to monitor the situation.

LPV-03.2b.1- Landside Runoff The Corps' contractor is installing vinyl sheet pile on the reach south of W. Esplanade Ave. Over one half of the pilings have been installed so far.

The Corps is preparing plans for additional work on sections north of West Esplanade Ave, which will include enlarging the existing swale (North of Vintage) by moving the western edge of the swale approximately 20' closer to the floodwall.

LPV-144A – Removal of Old Bayou Dupre Gates The pre-construction meeting for this project was held on May 10, 2016. Under this project, the contractor will remove the existing steel sector gate leaves and replace them with a fender system. The existing concrete structure will remain. Submittals and fabrication plans are in review by the Corps. Site work will begin by in mid-July.

LPV-145A – Bayou Bienvenue A pre-final inspection was held on April 27, 2016, and the bridge worked with no problems. A punch list was prepared noting minor deficiencies. All deficiencies were repaired by the contractor, and the NCC was issued on May 20, 2016.

LPV-149 – Caernarvon Structure The Corps has issued a contract for repainting the Sector Gate leaves to address peeling paint problems discovered after the Notice of Construction Complete (NCC) was issued. Work will not commence until November of 2016 to allow marine businesses in the area to plan for the closure of the Caernarvon Canal.

OFC-07 London Avenue and 17th Street Remediation An inspection was held at Reach 35B on June 8, 2016 and the turf was found to be acceptable. The reach has been turned over to the OLD for maintenance. The OLD has already begun normal maintenance activities on all other reaches.

Permanent Canal Closures and Pumps (PCCP) A status update for the three pump stations was sent to all Commissioners on May 6, 2016. The Corps has requested an extension of the Authorization for Entry (AFE) for the new structures to December 31, 2018. Construction of the new facilities is expected to be completed before then, but the decommissioning of the temporary structures will require the use of the same general area up through December 31, 2020.

A meeting was held with the Corps on May 2, 2016, to discuss required temporary openings in the existing floodwalls along the London Avenue and Orleans Avenue Canals to allow for construction of new T-Walls. The plan calls for sections of the existing walls to be degraded to elevation +5.5. The Corps and their contractor finalized their emergency closure plans for the wall openings for the upcoming hurricane season. The opening at London Ave Canal is now open, and the opening at Orleans Ave Canal will be opened in September of this year. Materials are on site should an emergency closure be necessary.

Please check the New Orleans District web site at www.mvn.usace.army.mil/missions/hsdrrs/pccp.aspx for details and regular updates on this last, major HSDRRS perimeter project.

SBPS-07 – Repairs to LBBLD Pump Stations #2 and # 3 The major work at Pump Station #3 is complete. The contractor is completing the work at Pump Station #2. A contract modification must be finalized to add a stop log gate near Station #2. A Red Zone inspection was held on May 31, 2016, and a pre-final inspection will be scheduled to document punch list items.

Armoring Work continues on the Orleans lakefront levees (ARM-02) and the New Orleans East Levee (ARM-04). A status update on all Armoring projects was sent to all Commissioners on June 6, 2016.

The Corps has provided SLFPAE with a cost estimate of \$2.8M for adjusting all of the land side levee slopes on LPV-111.01 to 1V on 3H. SLFPAE has requested that the Corps add this work to the upcoming armoring project at full federal expense.

Levee Lifts Prior to USACE Armoring We are pushing ahead with plans to raise some levees, at local cost, before they are armored. The intent is to save millions of dollars in future armoring replacement costs by raising the lowest levees now in advance of armoring in order to extend the life of armored levees. SLFPA-E and CPRA have been working with the Corps to complete the Environmental Assessment and secure the necessary USACE Section 408 Permits.

Three design firms are now under contract with SLFPA-E to prepare plans and specs for the levee raisings in EJLD and N.O. East. The status of each projects is listed below:

1. LPV 00.2 P&S approved by USACE-MVD. The P&S have been submitted to USACE HQ and we anticipate receiving 408 permit from USACE in July 2016. CUPs permit in hand.

2. The 100% LPV 1.1 and LPV 2.2 designs from our AE Firm were submitted to USACE-MVN on April 25, 2016. The CUP permit for this project was received in mid-May. USACE-MVN to submit to USACE-MVD in June for 408 Approval.
3. The 100% LPV 19.2 and LPV 20.1 designs from our AE Firm were submitted to USACE-MVN on April 25, 2016. The CUPS permit in hand. USACE-MVN to submit to USACE-MVD in June for 408 Approval.
4. EA for LPV 109, and LPV 111 submitted to USACE-MVN May 18th 2016.
5. LPV 109.02 95% P&S submitted to USACE-MVN by May 27, 2016. CUPs permit received June 2nd.
6. At the request of SLFPA-E, the Corps has agreed to raise approximately 4,000LF of the levee prior to armoring. Orleans Levee District will pay for the cost of the lift. LPV 111 MOA/MOU is undergoing USACE and CPRA legal review and will need to be signed by CPRA, SLFPA-E and USACE before design can begin.

Mississippi River Projects

Jefferson Heights The Corps' contractor continues raising segments of the Mississippi River Levee in East Jefferson approximately two feet. Work began at the Orleans Parish end and is moving toward Kenner. The first 4.2 miles has been raised. The contractor is working on punch list items, including turf establishment and bike path asphalt repairs.

Phase 2 includes 4.5 miles of levee between Orchard Road in River Ridge and the Jefferson-St. Charles Parish line. The final lift for Phase 2 has been completed and the levee is at final grade. Site work, turf establishment and replacement of the asphalt bike path is ongoing. Several business owner ramps are under construction. Tree removal and grass seeding is scheduled to begin this week at the upstream reach of this Phase. The project is 92% complete. Substantial completion is scheduled for July, 2016.

The recent high river stages delayed construction work and an extension of the Authorization for Entry (AFE) was signed.

Internal Affairs

Surge Analysis Update We continue to discuss internally and with others in the coastal science community the best path forward to accomplish a Hurricane

Surge Analysis update over the next several years. The newly formed Maurepas-Pontchartrain Surge Consortium is also showing significant interest in the surge update, and we are meeting with the group monthly.

On May 31, 2016 we met with representatives of CPRA and Arcadis to discuss a phased approach for the work. Arcadis has agreed to develop a Scope of Work (SOW) and approximate cost for the initial planning phase of the work. We expect a written proposal within the next 30 days.

Non-Federal Levee Certification Plans and specifications for both phases of the levee realignment near the Violet Canal are complete. However the property owner for the Phase I work (soap factory) requested a realignment of the levee prior to granting the ROE. The landowners approved the new and donated the remaining required right of way. There is a tenant in a mobile home on the old soap factory right of way (Fr. Luke Nguyen) who will be displaced by the project. He has until July 12, 2016 to vacate the property. The levee district is working with him to purchase a replacement mobile home and move into it as soon as possible.

The Benefit/Cost Analysis necessary for securing hazard mitigation grant funds for Phase II work was completed and submitted to GOHSEP, who reviewed it and passed it on to FEMA as “Cost Effective” with no other comments.

The Phase I (soap factory) Coastal Use Permit (CUP) was approved by the parish on April 7, 2015, and the Phase II (shrimp factory) CUP was approved in July, 2015.

Asset Management Phase 2 of the work to develop the software and data base necessary to effectively schedule and track operation and maintenance activities on our Complex Structures is ongoing. Teleconferences are scheduled every two weeks for status reviews and discussion of issues. A working template with dashboards is expected to be ready for user testing by the end of June, 2016.

Levee Inspection Tool The Orleans Levee District continues to phase in the implementation of the new Levee Inspection Tool. JBM Technologies has been awarded a contract to develop software to facilitate electronic collection of inspection points during a flood fight on the Mississippi River Levee.

Emergency Preparedness and Response The Mississippi River stage at the Carrollton gage is finally below 11.0' and is forecast to continue to fall.

Preparations continue for the 2016 Hurricane season.

Tidal Gage Network The Corps has submitted three AFE requests for hardened tide gage station sites at Delacroix, Breakwater Park and Chef Menteur. The CPRA is preparing the necessary documents and checking property ownerships; we are awaiting project plans and specifications from the Corps before issuing the AFE.

We have executed a contract with Weatherflow, Inc. for installation of a "hardened" weather station at the Bayou Bienvenue Lift Gate (\$30,287.25). The new station should be fully operational by July 1, 2016.

Periodic Inspection All unacceptable PI items have been field-verified and photographed. Required information was submitted to the CPRA with the recommended resolutions in December, 2015.

A list and course of action for all remaining minimally acceptable items is being finalized. This work is ongoing, and a meeting was held with the CPRA to formulate an official response to the Corps. The non-federal sponsor's official response is due to the Corps no later than December 2016.

Risk Assessment The Risk Assessment Project was awarded to Tetra Tech Inc. with a Scope of Work that includes a Probabilistic Performance Analysis for the Lake Borgne Surge Barrier, the Seabrook Complex and gates, and Sector Gates at Bayou St. John, Bayou Bienvenue, Bayou Dupre and Caernarvon. The analysis will identify and address the possible risk of failure or breakdown of any mechanical system within these structures that could cause flooding in parts of Orleans, Jefferson and St. Bernard parishes. The results of this work will help to inform operation and maintenance plans for the structures.

Phase I is complete. Phase 2 of the work has been authorized and a kick-off meeting was held on May 4, 2016 with our Consultant and the OLD maintenance staff to discuss results of the Phase 1 Report and develop a path forward for the remaining work.

ID-IQ Contracts In response to our Request for Qualifications (RFQs), One hundred and eleven (111) Statements of Qualifications were submitted on May 13, 2016. The six disciplines (as approved by Board Resolution) are: Surveying, Geotechnical, Hydraulics, Coastal, Inspection and Civil Engineering.
